# The Qualifications Wales Transfer (No. 2) Scheme 2015

Made 16 September 2015

Laid before the National Assembly for Wales 16 September 2015

Coming into force 21 September 2015

The Welsh Ministers, in exercise of the powers conferred by section 2(3) of and Schedule 2 to the Qualifications Wales Act 2015(1), make the following Transfer Scheme.

#### Title and commencement

- 1.—(1) The title of this Scheme is the Qualifications Wales Transfer (No. 2) Scheme 2015.
- (2) This Scheme comes into force on 21 September 2015.

### Interpretation

#### 2. In this Scheme—

"collective agreement" ("cydgytundeb") and "collective bargaining" ("cydfargeinio") have the same meaning as in the Trade Union and Labour Relations (Consolidation) Act 1992;

"members of staff" ("aelodau o staff") means the members of staff transferring under article 3 of this Scheme;

"records" ("cofnodion") include written records and records conveying information by any other means.

# Transfer of members of staff of the Welsh Government and continuity of employment

**3.** On 21 September 2015, the members of staff whose Welsh Government staff numbers are listed in this article transfer to the employment of Qualifications Wales—

**4.** On 21 September 2015, the Welsh Ministers' rights, powers, duties and liabilities under or in connection with the contract of employment of the members of staff are transferred to Qualifications Wales, but see article 5.

#### 5. Article 4 does not—

- (a) transfer or otherwise affect the liability of any person to be prosecuted for, convicted of and sentenced for any offence; or
- (b) transfer any rights, powers, duties or liabilities in relation to any provision of a collective agreement if that provision is agreed on or after 21 September 2015 and Qualifications Wales was not a participant in the collective bargaining for the provision.
- **6.** The period of continuous employment of the members of staff is not broken by the transfer to the employment of Qualifications Wales.
- **7.** The contract has effect after the transfer as if originally made between the member of staff and Qualifications Wales except that it has effect as if it does not incorporate provisions of a collective agreement described in article 5(b).
- **8.** Anything done or omitted to be done by the Welsh Ministers before 21 September 2015 in relation to the contracts of employment of the members of staff is treated on or after 21 September 2015 as having been done or omitted to be done by Qualifications Wales.

# Transfer of the property, rights and liabilities of the Welsh Ministers

- **9.**—(1) On 21 September 2015 the following matters transfer from the Welsh Ministers to Qualifications Wales—
  - (a) the property listed in Part 1 of the Schedule, and the associated rights and liabilities;
  - (b) the rights and liabilities listed in Part 1 of the Schedule;
  - (c) the grants agreements falling within the categories of grants agreements listed in Part
     2 of the Schedule and the associated rights and liabilities;
  - (d) the documents and records listed in Part 3 of the Schedule and the associated rights and liabilities.
  - (2) This article does not transfer Crown copyright.

#### **10.** For references to—

- (a) the Welsh Ministers;
- (b) the First Minister;
- (c) the Welsh Government;

- (d) the Welsh Assembly Government;
- (e) the National Assembly for Wales;
- (f) the National Assembly; and
- (g) the Assembly,

substitute Qualifications Wales in any agreements, contracts or legal proceedings which relate to any property, rights or liabilities transferred by this Scheme unless the contrary intention applies.

# Crown copyright

- 11.—(1) Where the matters listed in the Schedule are subject to Crown copyright, from 21 September 2015 the Welsh Ministers grant Qualifications Wales a licence to use Crown copyright materials as Qualifications Wales may require in order to carry out its functions subject to the requirement in paragraph (2).
- (2) Qualifications Wales must use the materials for their intended purpose and must not use the materials in any manner which could bring the reputation of the Welsh Ministers into disrepute.
- (3) The Welsh Ministers may review the use of such materials by Qualifications Wales in order that they may satisfy themselves that there has been no failure to comply with the requirement in paragraph (2).
- (4) The Welsh Ministers may terminate or modify the licence granted by this Scheme and may remove specific matters from the scope of the licence.

#### Access to documents and records

- 12.—(1) Where the Welsh Ministers hold records or documents which relate to or are connected with the property, rights, and liabilities transferred to Qualifications Wales under this Scheme, but which do not transfer, the Welsh Ministers may provide to Qualifications Wales any such record or document on such conditions and subject to such restrictions as the Welsh Ministers consider appropriate.
- (2) Where records and documents have transferred to Qualifications Wales under this Scheme, the Welsh Ministers may, after providing reasonable notice to Qualifications Wales, take or be supplied with copies of those records or documents, or any part of them.

#### **Modification of this Scheme**

**13.**—(1) The Welsh Ministers may modify this Scheme by agreement with Qualifications Wales.

(2) Modifications may have effect from 21 September 2015.
