**The Deputy Minister for Children and Social Services (Gwenda Thomas):** Local authorities already have a duty, under the Carers and Disabled Children's Act 2004, to inform carers of their right to a carers assessment. To help ensure that carers get the information they need, at the right time and in the right format, the Welsh Government has brought forward the Carers Strategies (Wales) Measure 2010. This requires Local Health Boards to work with Local Authorities in preparing local strategies to identify, consult, and provide information and training to carers of all ages. We expect these to include information and awareness raising around carers assessments. Following consultation Regulations to implement these changes will be laid shortly. We will also consider carers assessments as part of the refresh of the Carers Strategy for Wales in 2012.

**Gwenda Thomas:** Local Health Boards and local authorities are currently required to actively engage service users and carers in developing, implementing and reviewing their local Health, Social Care and Well-Being Strategies. From April 2013, Local Service Boards will be required to produce a single integrated plan for their area, drawing together and replacing a range of existing plans including Health Social Care and Well-Being Strategies, Children and Young People's Plans, Community Safety Plans and Community Strategies. These Integrated Plans will focus on delivering positive outcomes for people and communities, and will be used by the Inspectorates and the Wales Audit Office to determine whether local authorities and their partners are setting the right priorities and delivering improved well-being, and

that appropriate governance and accountability mechanisms are in place. We will expect the needs of carers to be continue to be addressed in these Plans.

In addition, during 2012 we will be taking forward our Programme for Government commitment to refreshing the Carers Strategy for Wales. In doing so we will consider what further measures we might need to put in place to promote the health and well-being of carers, making connections with other national and local strategies as necessary. We will, of course, ensure that there are measures in place to evaluate the success of the refreshed Strategy.

**Gwenda Thomas:** Earlier this year, I raised with Maria Miller MP, the Minister for Disabled People, my concerns about the potential impact upon carers of changes to Disability Living Allowance (DLA), given that the Carer's Allowance is a 'passported' benefit. We will continue to seek reassurances that carers will not be disadvantaged as a result of the UK Government's welfare reforms. Our Ministerial Task and Finish Group will also be assessing the cumulative impact of these welfare reforms on citizens and services in Wales.

**Lesley Griffiths:** A specific working group has been set up under Free to Lead Free to Care to address the National Audit recommendations related to nursing practice. The group is chaired by Ruth Walker, Nurse Director of Cardiff and Vale University Health Board. It is also incorporating the recommendations made by the All Wales Continence Forum. Additionally, the Medical Director NHS Wales has written to all Health Boards in Wales to ensure steps are being taken fully to implement National Clinical Audit findings on Continence Care.

We also intend to issue the following web-based documents to the NHS in Wales: "All Wales Children & Young People's Continence Guidance and Care Pathway" (doc 1) and "All Wales Paediatric Bladder and Bowel Dysfunction Continence Care Policy" to resolve inequities in the provision of continence care for children and young people in Wales with bladder and/or bowel dysfunction problems
