I have not made a specific assessment in that regard. The majority of money granted by the Welsh Assembly Government to Local Authorities is not specifically earmarked for education. Local Authorities are responsible for funding their schools and must do so in the way that ensures best use of public money and the best outcomes for pupils – this continues to be the case.

The WLGA has pledged to increase delegation from the current 75%. They have committed to increase it to 80% in two and 85% in four years.

The nature of the target and the numbers were offered by local government, not set by me. It is a positive move. It chimes strongly with the themes identified by PricewaterhouseCoopers; it will increase the proportion of schools expenditure that schools themselves have control of and I welcome it.

I refer you to my letters of 6 and 14 January updating Assembly Members with the Adult Neuroscience Review.

The delivery of neurosurgery in line with waiting times targets is a matter for Cardiff and Vale University Local Health Board. The neurosurgery service is now fully integrated onto the University Hospital of Wales site, clinical staff have been transferred, new dedicated theatre facilities are fully operational and new ward facilities became operational in January.

The number of on farm inspections required is governed by European regulation and therefore remains in line with these requirements.

As part of the ongoing review of on-farm red tape, the burden on farmers is being reduced by coordinating inspections where a farm is required to be inspected for more than one reason. As a result of this co-ordination the total number of separate visits has been reduced by 290, due to joint inspections being carried out in 2010.
