CALCULATION OF GRANT PAYABLE TO AUTHORITIES

- 1. Grant is to be paid in 2002/3 to every county council and county borough council in Wales that has the functions of a local education authority ("the authority") and provides education support for asylum seekers who have come to Wales as a result of the Home Office dispersal arrangements. The level of grant has been calculated on the basis of the best available information of the additional costs that will be incurred by making provision for the specified group of people.
- 2. It has been estimated that the total amount of grant required for 2002/03 is likely to be £1,284,345 although this may fluctuate depending on the level of dispersal.
- 3. The amounts of grant payable to each authority will be calculated as follows:

- 5. The grant will be payable in two instalments, the first in December 2002 to cover the costs of February 2002 to October 2002 and the second in the February 2003 to cover the costs of November 2002 to January 2003.

The purpose of the grant is to enable local authorities to provide additional administrative support in targeted schools, that will relieve teachers and headteachers of routine administrative tasks and allow them to concentrate on their teaching and leadership duties in order to help drive up standards of pupil achievement.

Subject to the following provisions, local authorities can decide how to use the funding most effectively in order to achieve the above objective. In doing so they are to take into account the list of 24 clerical and administrative tasks listed at Annex C and how teachers may be relieved of carrying out these tasks as a matter of routine. This reflects the proposed changes the Secretary of State for Education and Skills is expected to make to the School Teachers' Pay and Conditions Document from September 2003. Local authorities will be required to target the funding in Annex A at those schools considered likely to be most affected by the need to relieve teachers from carrying out the 24 tasks. The majority of these are expected to be smaller schools in the primary sector.

Local authorities should nonetheless also bear in mind the needs of:

- the Welsh medium sector, for example the employment of additional administrative support to assist with the preparation or translation of materials into Welsh; and
- leadership groups in secondary schools.

Local authorities must use the funding to benefit schools by enabling them to employ additional administrative support. This may be administrative, clerical, secretarial, financial management or pupil behaviour support; or any other form of support to teachers or the leadership group and headteachers that will help to achieve the objective at paragraph 1 above.

Where practical, local authorities will be expected to make maximum use of the sharing of posts between schools - whether through clusters, federations or informal associations – where this maximises the potential benefits of additional support, particularly in the case of smaller schools. Local authorities may also use the funding to enable schools to make more or better use of existing administrative staff in schools, for example by increasing their hours, rather than employ new staff.

The funding provided to each of the targeted schools must be sufficient to enable them to employ additional staff (whole time, part time or shared between schools) or to increase the time existing staff are employed so that the objective can be met.

It includes detail on the distribution of the Rural and Small Schools Grant which is worth £3.5m this financial year and was distributed according to the following formula: 70% sparcity index, 20% number of small schools and 10% deprivation index.

The grant is intended to help local authorities and schools drive up standards and improve their effectiveness, by a variety of means. Local authorities can decide how to use the funding most effectively to improve organisation and standards but must use it in full to benefit schools. Authorities may use the sums in Column A of Annex A to assist with developing schemes for schools, particularly small and rural schools, to work together, whether through informal association, collaboration, clustering, federation or IT networking or any other appropriate means of co-operating to work more effectively to raise educational standards. The funds are intended to facilitate change and may be deployed by schools to assist with the administrative costs of managing change and developing new schemes; or for additional facilities or equipment. They may be used to support the development of schemes to increase the community use of school buildings, which might be for pre-school groups, after school activities, adult education, ICT centres, libraries or for non educational community purposes or to provide administrative support particularly to Headteachers who have a significant timetable teaching commitment. The funds may also be used by LEAs in supporting schools engaged in developing innovative schemes.

Authorities must use the sums in Column B of Annex A to support achievement of the pupil level annual school census specified below.

- That all primary, secondary, special schools and pupil referral units in the relevant local authority area achieve at least baseline levels of hardware and software and have staff competent to use the systems;
- That by January 2004 they have the information complete and up to date on these systems for those items included in the pupil level annual schools census (PLASC); and
- That by May 2004 they hold and can transfer electronically all defined items of pupil data that need to be transferred from school to school.

In support of this the funding may be used for training of relevant staff, provision of ICT hardware and software in schools.
