- **Cynnig I gymeradwyo o dan Reol Sefydlog 24.25(1 munud )**
  - **The Street Works (Inspection Fees) (Wales) Regulations 2006**  
The New Roads and Street Works Act 1991 provides the framework within which utilities must carry out works in the highway to install or access their equipment buried under the road or in the footway. The Act provides also for the co-ordination and inspection of utility street works by highway authorities. These Regulations reform the present basis on which highway authorities may charge for carrying out a proportion of their routine inspections of utilities' street works.
  - **The Food Hygiene (Wales) (Amendment) Regulations 2006**  
The proposed legislation will correct two inconsistencies between the Welsh and English texts of the Food Hygiene (Wales) Regulations 2006.
- **Cynnig i gymeradwyo Rheoliadau Salmonela mewn Heidiau o Frwyliaid (Pwerau Arolygu) (Cymru) 2006 (20 munud)**  
Daeth Penderfyniad y Comisiwn 2005/636/EC i rym ar 1 Medi 2005, ac mae'n ei gwneud yn ofynnol i bob un o Aelod-wladwriaethau'r UE gynnal arolwg 12 mis, i ddechrau ar 1 Hydref 2005, o heidiau o frwyliaid *Gallus gallus* (adar domestig), i bennu lefelau o filheintiau Salmonela (bacteriwm, firyssau, paraseitiaid neu gyfryngau trosglwyddadwy eraill) sydd o bwys i

iechyd y cyhoedd ledled y Gymuned. Rhaid i Aelod-wladwriaethau gyflwyno adroddiad terfynol o'u canfyddiadau i'r Comisiwn erbyn 31 Hydref 2006. Bydd y Rheoliadau hyn yn darparu pwerau mynediad i arolygwyr gymryd samplau a phwerau cysylltiedig eraill i ofyn am gydweithrediad cynhyrchwyr gyda'r arolwg. Ar hyn o bryd, mae arolygwyr yn ddibynnol ar ewyllys da ffermwyr i gael mynediad at ddiben yr arolwg, a ddechreuodd ar 1 Hydref 2005.

- **Cynnig I gymeradwyo The Housing Act 2004 (Commencement No3 and Transitional Provisions and Savings) (Wales) Order 2006 (15 munud )**

This Order commences certain provisions in the Housing Act 2004 relating to the Housing, Health and Safety Rating System (HHSRS); Licensing of Houses in Multiple Occupation (HMO); Additional HMO Licensing; Selective Licensing of Other Residential Accommodation and the jurisdictions of the Residential Property Tribunal (RPT). It also contains transitional arrangements in the Schedule. The latter primarily relate to pre-existing HMO registration schemes (containing control provisions or special control provisions), which can be 'passported' as new licensing regimes when the registration scheme expires. The legislation also allows other transitional arrangements (not defined) be made if the National Assembly considers it appropriate.

- **Cynnig i gymeradwyo The Bovine Spongiform Encephalopathies (BSE) Compensation (Wales) Regulations 2006 (15 munud)**

These Regulations will introduce a rationalised compensation system for cattle suspected of having Bovine Spongiform Encephalopathy (BSE). Separate legislation, namely The Cattle Compensation (Wales) Order 2006, has been proposed to introduce the new system in respect of Bovine Tuberculosis (TB), Brucellosis and Enzootic Bovine Leukosis (EBL). Under this system, compensation will be determined using Table Valuations, based on average market price for pre-determined cattle categories. There is also a provision for individual valuations to be used, at the discretion of the Assembly, should supporting sales data be inadequate or unavailable for a particular category in any particular month or months.

- **Cynnig i gymeradwyo The Sheep and Goats Transmissible Spongiform Encephalopathies (TSE) Compensation (Wales) Regulations 2006 (15 munud)**

These Regulations will allow for the adjustment of compensation rates for ewes/female goats and lambs/kids killed and destroyed under the Compulsory Scrapie Flocks Scheme. The proposed adjustment in compensation rates will bring them in line with market values thus reducing the risk of possible abuse under the current scheme. The Regulations will also allow for new provisions for the arrangement of a

valuation in exceptional circumstances to enable clear cases of overpayment to particular flocks to be addressed.

- **Cynnig i gymeradwyo The Code of Practice to Prevent and Control the Spread of Ragwort 2006 o dan Reol Sefydlog 29 (15 munud)**

The Code is a practical guide to help public bodies, relevant authorities, owners and occupiers of land to control the spread of common ragwort only. It is not the intention of the Code to seek to eliminate common ragwort, nor to seek to control the spread of ragwort where it does not pose a threat to the health and welfare of animals, the production of feed or forage or other agricultural activities.

The Code will also strengthen enforcement and makes clear what is considered reasonable action to comply with the enforcement action, served under the Weeds Act 1959.

  - **The Plant Health (Wales) Order 2006**

This Order will implement a number of European Directives in Wales, which amend Council Directives 2000/29/EC and 2002/89/EC. Directive 2000/29/EC establishes the Community plant health regime and contains measures to prevent the introduction into, and spread within the Community, of serious pests and diseases of plants and plant produce. Directive 2002/89/EC introduces significant changes to the regime for checks on third country imports. In addition, this Order will consolidate the various amendments made to the existing Plant Health (Great Britain) Order, since it was introduced in 1993.

  - **Cynnig I gymeradwyo The Residential Property Tribunal Procedure (Wales) Regulations 2006**

These Regulations set out the procedures to be followed by residential property tribunals (RPTs) in determining applications and appeals in Wales under the Housing Act 2004 or Part 9 of the Housing Act 1985. Applications and appeals to which these Regulations apply are as follows:

    - appeals from costs jurisdictions;
    - appeals against a lack of discretionary management orders;
    - approval of empty dwelling management orders;
    - appeals improvement notices;
    - appeals against interim empty dwelling management orders;
    - authorisation of interim management orders;
    - approval of lease varying orders; and
    - applications for powers and procedure orders.

- **Cynnig I gymeradwyo The Residential Property Tribunal (Fees) (Wales) Regulations 2006**

These Regulations set out the fees that are payable where specified appeals and applications are made to a residential property tribunal (RPT).

- **Cynnig I gymeradwyo The Avian Influenza Vaccination (Wales) Regulations 2006 o dan Reol Sefydlog 24.27(iv)**

This Order and Regulations will transpose the Avian Influenza Directive (EC Directive 2005/94) setting out controls for Avian Influenza. The transposition will principally consist of incorporating into the transposition Orders the substance of the Avian Influenza (Preventive Measures) (Wales) (No. 2) Regulations 2005 and the Avian Influenza (Preventive) Measures in Zoos (Wales) (No. 2) Regulations 2005 made last December to implement Commission Decisions, which expire at the end of December 2006. The Commission Decisions respectively are 2005/734 /EC as amended by 2005/745/EC and 2005/744/EC.

- **Cynnig I gymeradwyo The Firefighters Pension (Wales) Scheme (Amendment) Order 2006 (15 munud)**

This Order makes a number of amendments to the Firefighters' Pension Scheme to reflect changes in other legislation, such as the introduction of the Civil Partnership Act 2004; to correct anomalies that have arisen, such as the changes in terminology relating to the Service; and to reflect other changes that have occurred as a result of UK-wide consultation, such as the replacement of compulsory retirement age with normal retirement age.
