During Plenary on 1 Eebruary 2017, I stated I would provide an update in relation to the potential bat roost at the Mynydd y Gwair development. My officials have contacted both the Local Authority and the developer in order to establish the most recent position on this matter.

As you are aware, there have been concerns in relation to the potential bat roost in trees scheduled for removal along the access road and Bioscan, who are consultant ecologists, were commissioned to provide a report entitled 'Tree Survey – Bat Roosting Potential.'

The report focused on the trees to be felled as part of the construction works. It concluded there are a number of trees along the access road that will need to be removed, which have been inspected on a number of occasions for their potential to roost bats. However no bat roosts have been found in any of the affected trees.

The report states '...While a suspected maternity roost of noctule bats was confirmed in June - July 2015, this is in a tree some distance from the proposed construction works.' The tree in question is an ash tree situated to the East of the access road and this tree is due to be retained.

Following a conflicting report from Dr David Waterhouse, a recent site meeting was organised, attended by Bioscan, the developer Innogy, the Local Authority's own ecologist, and Principal Planner David Owen. The site visit was held to physically identify the tree in question.
