## PESTICIDES, ENGLAND AND WALES

# AMENDMENT TO THE CODE OF PRACTICE FOR USING PLANT PROTECTION PRODUCTS: DRAFT PARAGRAPH 3.7.4

## Summary

The Code of Practice for Using Plant Protection Products was introduced by the Welsh Assembly Government, the Department for Environment, Food and Rural Affairs (Defra) and the Health and Safety Commission (HSC) on 15 December 2005. The Code replaced the previous Code of Practice for the safe use of pesticides on farms and smallholdings published in 1990 (The Green Code). It also combined the non-statutory Code of Practice for the use of approved pesticides in amenity and industrial areas and parts of the Code of Practice for the safe use of non-agricultural pesticides.

Paragraph 3.7.4 of the Code of Practice deals with the use of pesticides in or near public access areas and public rights of way. This paragraph is now being amended to correct an error in the original paragraph, where it refers to legislation which is yet to be brought into force.

- 1. This Memorandum is submitted to the Assembly's Business Committee in relation to the Amendment to the Code of Practice for Using Plant Protection Products: Draft Paragraph 3.7.4, in accordance with Standing Order 25 section 3.
- 2. A copy of the amendment to the Code is submitted with this Memorandum.

#### **Enabling Power**

- 3. The power enabling this amendment to the Code to be made is contained in section 17 of the Food and Environment Protection Act 1985. Responsibility for issues relating to the contents of the Code has been delegated to my portfolio as Minister for Environment, Planning and Countryside. The amendment to the Code is being made together with England.
- 4. As part of the Code is approved under the Health and Safety at Work etc Act 1974, the formal approval of the Health and Safety Commission has been obtained for the amendment to Paragraph 3.7.4 of the Code. It has been endorsed by Ministers in the Department for Work and Pensions. Also, as an approved Code under the Groundwater Regulations 1998 and the Food and Environment Protection Act 1985, both Department for Environment, Food and Rural Affairs (Defra) Ministers responsible for these areas have endorsed it.

5. The amendment to this Code could have been made on a Wales only basis. However, to do so would have been impractical as the Department for Environment, Food and Rural Affairs' Pesticides Safety Directorate (PSD) have the technical and scientific expertise to make this Code. In addition, PSD are the lead UK agency in terms of policy and enforcement for agricultural pesticides in England and Wales.

#### **Effect**

- 6. The Code sets out the best practice for the use of pesticides, which are controlled under the Control of Pesticides Regulations 1986, the Plant Protection Products (Basic Conditions) Regulations 1997 and the Plant Protection Products Regulations 2005. The Code's statutory basis means that it can be used in evidence if anyone is taken to Court for a breach in pesticide, health and safety at work or protection of groundwater legislation.
- 7. This amendment to the Code of Practice was necessitated by a Judicial Review pre-action protocol letter sent to Defra Ministers on 21 March 2006. The letter brought to the attention of the Pesticides Safety Directorate and Defra that there was an error in the 2006 Code in a paragraph (paragraph 3.7.4) dealing with the Countryside and Rights of Way Act 2000 (CRoW).
- 8. Section 135A of the Highways Act 1980, which was inserted by the CRoW Act but has not yet come into force, (a date for the coming into force has yet to be determined), will allow for the temporary diversion of a footpath or bridleway by the occupier of the land following a completion exercise where "works of a prescribed description are likely to cause danger to users" of the way. The "works" to be prescribed under section 135A (when it has been brought into force) have yet to be determined.
- 9. Paragraph 3.7.4 of the 2006 Code suggested that landowners may temporarily close public rights of way, under provisions in the CRoW Act 2000 (section 135A of the Highways Act 1980, as inserted by the CRoW Act), when applying (or having applied) pesticides, and that landowners may apply to the relevant authorities for access to be restricted in this manner. However, this information is incorrect as it refers to legislation that has yet to be brought into force.
- 10. The amendment to paragraph 3.7.4 of the Code will correct this error.

#### **Target Implementation**

- 11. It is intended that the amendment to the Code be made on 25 October 2006 and come into force on 24 November 2006. If the intended target dates are not achieved and the Code is not amended, there is a risk of a legal challenge.
- 12. The Scottish Executive Environment and Rural Affairs Department is expected to issue their own version of the Code of Practice within the next 7 weeks. They have been informed of the pre-action protocol letter. However, the text of the similar paragraph in their Code is not the same as the England/Wales version. Therefore, there is no need for them to make any amendment.
- 13. The Department of Agriculture in Northern Ireland are currently updating their edition under their legislation. They are aware of the pre-action protocol letter.

Any new Code they publish will follow the amendment made to the England/Wales version.

## Regulatory Appraisal

14. As this amendment to the Code falls outside the definition of Assembly subordinate legislation in section 58 of the Government of Wales Act 1998, a Regulatory Appraisal is not required to be undertaken.

#### **Financial Implications**

- 15. The Code is available electronically free of charge in English via the Department for Environment, Food and Rural Affairs' Pesticides Safety Directorate's website and will be made available in Welsh from the Welsh Assembly Government's website. Therefore, there are no cost implications for the industry arising from this legislation.
- 16. Hard copies are available in English from Defra Publications for £17 (includes £2 postage and packing). Defra will include an erratum slip with those copies held in stock.
- 17. Publication of the Welsh language version of the Code was postponed as soon as officials were made aware of the error in the current text. It is anticipated that hard copies of the Welsh language Code will be made freely available before the end of this year. In accordance with the Assembly Publications Scheme, we do not charge for publications. Any publication costs will be accommodated within the Plant Heath Services Budget Expenditure Line.
- 18. There are no additional costs for the industry associated with the implementation of the amended Code.

#### Consultation

#### With Stakeholders

- 19. The Pesticides Safety Directorate (PSD) conducted a consultation on the amendment to paragraph 3.7.4 of the Code between 15 June 2006 and 28 July 2006, principally with those who commented on this particular paragraph in the original consultation.
- 20. As this was a single specific issue, and in view of the risk of legal action if there was undue delay in amending the Code, the consultation lasted for only 6 weeks. A list of those consulted is attached at Annex A.
- 21. Although no one from Wales responded to this particular part in the original consultation, Welsh Assembly Government officials copied the PSD's revised consultation, for information purposes, to those Welsh stakeholders and interested parties included in the original consultation. A list of those parties is at Annex B. The Countryside Council for Wales, The Brecon Beacons National Park, The Welsh Consumer Council and The Wales Council for Voluntary Action responded to the PSD. However, no substantive changes were proposed.
- 22. The PSD received 18 replies to the consultation and copies are available to the public from the Department for Environment, Food and Rural Affairs' Library. These responses were carefully analysed and the vast majority were applied to

the new paragraph. A summary of the results of the analysis is attached at Annex C and can also be found in the Defra Library.

#### With Subject Committee

23. The amendment to the Code was notified to the Environment, Planning and Countryside Committee, via the Minister's report on 13 July 2006 (EPC(2) 11-06(p1) Annex 1, item no: 2), but was not identified for detailed scrutiny.

#### **Recommended Procedure**

24. Subject to the views of the Business Committee, I recommend that the amended Code proceed to Plenary under the Standard procedure.

### Compliance

- 25. The proposed legislation will (as far as is applicable):
  - have due regard to the principle of equality of opportunity for all people (Government of Wales Act 1998 section 120);
  - be compatible with the Assembly's scheme for sustainable development (section 121);
  - be compatible with Community law (section 106);
  - be compatible with the Assembly's human rights legislation (section 107);

  - be compatible with any international obligations binding the UK Government and the Assembly (section 108).
