commitments to undertake projects have to be made by 31 December 1999, projects can continue post-1999. However, it does not necessarily follow that projects which have received grant under existing programmes will be successful under the arrangements for 2000-2006. Projects seeking future funding will have to comply with the specific criteria which have yet to be set for the new programmes.

Under existing programmes, all project sponsors are aware that they must have the necessary financial packages in place to deliver and sustain their projects over the period of time set by their grant approvals.
