The Code is based on three core principles – merit, openness and fairness – and sets out the essential requirements for meeting those principles.

Executive Board members will be appointed either as a result of staff transfer from the three bodies or where appropriate, by open competition.

Part 3 of the regulations imposes obligations on sellers who employ 10 or more full time equivalent staff members to maintain records and supply these records on request to either the public or the Welsh Government. In addition sellers who supply 1,000 or more bags per year are required to publish their records, either through their company website or in-store.

The actual spend on maintenance and upgrade of the Cathays Park offices for financial year 2011/12 was £7,114,526. In this year we were able to find additional money from savings generated across our running cost budgets. A proportion of this money was directed to our estate, accelerating works that we would otherwise need or want to do. Expenditure to date this financial year, as at 31 July, is £1,459,595.

Our annual programmes of work are designed to ensure that the Government's administrative estate supports its business needs, meets statutory requirements, protects building users from danger, delivers efficiencies through estate rationalisation, reduces environmental impact and retains its value as an important Welsh Government asset. Cathays Park is the main presence of the Welsh Government housing nearly half of all Welsh Government civil servants.

Over the five years of this Government's Location Strategy, our estate rationalisation plans are estimated to generate cumulative savings of over £18 million, bringing recurrent annual running cost savings in excess of £5.3 million from 2015, which represents a reduction of approximately 30% against current building occupancy costs. Investment in our estate also continues to benefit the construction sector and other local businesses.

Andrew RT Davies (**South Wales Central**): How much money has the Welsh Government spent on refurbishing, upgrading or general building maintenance on its Cathays Park Headquarters; giving figures for the last three years and projected costs for the next two financial years. (WAQ58231)

The Minister for Finance and Leader of the House (Jane Hutt): While Welsh Government took the decision in 2010 not to proceed with full scale refurbishment of Cathays Park, the main building is over 30 years old, and in common with any property of this age, requires replacement of major plant and equipment and ongoing maintenance - primarily to comply with Health and Safety legislation and ensure that the buildings remain operational.

Future expenditure will need to continue to target these priority areas and opportunity is also being taken to improve space use, which will deliver further operational cost efficiencies by enabling more estate rationalisation. Removal of old inefficient plant and systems and the installation of new, more efficient replacements also have a positive impact upon the sustainable operation of the building and help Welsh Government meet its statutory obligations to reduce carbon emissions.

Details of actual expenditure on refurbishing, up-grading and general maintenance for the Cathays Park offices for the last three full financial years and the projected expenditure for the current financial year are provided in the table below. The programme of works for the 2012/13 financial year has not yet been agreed.

Lesley Griffiths: On 18th July 2012, AWMSG appraised Everolimus (Afinitor®) for the treatment of unresectable or metastatic, well- or moderately-differentiated neuroendocrine tumours of pancreatic origin in adults. Their advice was to recommend its use in NHS Wales. Once the appraisal process is complete, this medicine will be available in NHS Wales for this indication.

My officials have not had any discussions with Hywel Dda Health Board, its Chief Executive or the IFPR Panel regarding the availability of Everolimus.
