**The Minister for Natural Resources and Food (Alun Davies):** The Arbed ERDF 2 project is a ring fenced European funded project which forms part of our wider programme of energy efficiency support. We will monitor how much ECO we draw in through our energy efficiency programme activity by monitoring our own results and collecting information from any partner organisations that we fund including local authorities.

**Alun Davies:** I have recently announced an additional £70m of funding for our programme of energy efficiency support. This funding will not be going directly into our Arbed 2 ERDF project which is a ring fenced European funded project. The £70m will be used alongside existing energy efficiency programme activity that includes Arbed 2 EDIF and Nest. The £70m of funding will be used to attract investment into Wales from energy companies through their energy company obligation ECO and will allow the number of households supported with energy efficiency improvements in Wales to be increased.

However, as I have also made clear several times now, the in-year financial adjustment in question will not affect the overall programme budget to be spent on the Rural Development Plan nor reduce our ability to draw down the associated EU funding.
