The Minister for Education and Skills (Leighton Andrews): A range of measures have been put in place to support schools in implementing the National Literacy and Numeracy Framework, which will become statutory in September 2013.

We are investing over £7m in the National Support Programme which offers direct support to schools and teachers to help them effectively implement the LNF. The first cohort of 339 schools began to receive direct support in June 2013.

On-line bilingual training materials were published in January this year alongside guidance on curriculum planning. Further training materials are currently in development. These cover guidance on assessment practices, and exemplar materials to enrich understanding of the LNF requirements and materials for use in the classroom. All of these will be published in September 2013.

The effectiveness of the teacher support package will be evaluated as part of the evaluation of the national literacy and national numeracy programmes, for which we are currently tendering. We are receiving helpful feedback from schools on the package of support being offered and we are using this information to adapt the support package if and where needed.
