## **Cymru 1996 (Dirymu) 2005 o dena Reol Sefydlog 25 (rhan 1) (15 munud)**

Bydd y trefniadau amddiffyn rhag llifogydd newydd yng Nghymru, a gyhoeddwyd yn y cyfarfod llawn ar 29 Mehefin 2004, yn arwain at strwythur pwyllgor amddiffyn rhag llifogydd un haen. Bydd y strwythur hwn yn disodli'r strwythur pwyllgorau dwy haen presennol sy'n cynnwys chwe phwyllgor amddiffyn rhag llifogydd lleol. O ganlyniad i'r Gorchymyn hwn, gellir diddymu'r chwe phwyllgor amddiffyn rhag llifogydd lleol yng Nghymru.

Yr Adroddiad yw rhan gyntaf yr adolygiad polisi tri cham. Mae'r adroddiad cychwynnol hwn yn canolbwyntio ar nodi ac ymyrryd yn gynnar. Bydd y camau diweddarach yn archwilio'r broses 'ddatganiadau' a'r problemau a gafodd plant a phobl ifanc sydd ag AAA wrth symud o un cam o'u haddysg statudol i'r llall, ac wedyn wrth fynd ymlaen i addysg uwch a'r byd gwaith. Cytunodd y Pwyllgor Addysg a Dysgu Gydol Oes ar yr Adroddiad ar 13 Hydref 2004 ac fe'i trafodwyd yn y Cyfarfod Llawn ar 24 Tachwedd 2004.

- **Rheoliadau Deunyddiau Plastig mewn Cysylltiad â Bwyd (Diwygio) (Cymru) 2005**

These Regulations implement two European Commission Directives, 2004/13/EC on the use of certain epoxy derivatives in materials and articles intended to come into contact with foodstuffs and 2004/1/EC on the suspension of the use of azodicarbonamide as a blowing agent in food contact plastics. These two Directives amend others that are implemented by one set of regulations, The Plastic Materials and Articles in Contact with Food Regulations 1998 (SI no 1998/1376) as amended (by SIS 2000 no 3162, 2002 no 2364 and 2002 no. 2008). The overall policy objective of the proposal is to secure a high level of human health and consumer interest protection, while ensuring the free movement of materials and articles intended to come into contact with food.

- **Cynnig i gymeradwyo o dan Reol Sefydlog 24.27 (iv) Diwygiadau i Reoliadau'r Dreth Gyngor (Newid Rhestri ac Apelau) 1993 (OS 1993/290) (15 munud)**

It is essential to introduce legislation by early February 2005 so as to allow sufficient time for councils, the Valuation Office Agency and the Valuation Tribunals to include the new dates on their

literature explaining the proposals and appeals process. This legislation is required to provide council tax payers with a right to make proposals to alter and appeal against the valuation of their property in the new lists which come into force on 1 April 2005. Without any amendment to the 1993 Regulations there will be no such right of appeal. The proposed amendments will set a deadline of 31 December 2005 for proposals to alter 1993 valuation lists (subject to three exceptions); allow proposals to alter the 2005 valuation lists to be made as of 1 April 2005; create a new deadline for proposals in respect of the 2005 list where a proposer considers that the listing officer has made an error in a valuation list as at compilation (a similar - now 'timed out' - deadline of 30 November 1993 was set for 1993 valuation lists which came into force on 1 April 1993).

The Report of the external Child Poverty Task Group was consulted on over the summer. The Child Poverty Strategy "A Fair Future for our Children" responds to the Task Group report, and sets out the long-term direction for the Welsh Assembly Government and its partners for combating child poverty.

- **Dadl ar y Strategaeth Diwydiannau Creadigol (60 munud)**

The Creative Industry Strategy has been set up to support and encourage Welsh based creative industries that can make a significant contribution to the economy in Wales. It will stimulate growth in the creative industries in Wales, both by encouraging more inward investment and encouraging more businesses to Wales. The key activity areas are the establishment of a new £7m creative I.P. fund, to secure work for Wales and better strategic investment in Wales based creative businesses; the introduction of a new strategic approach to provide business support for creative industries and the re-focussing of training and education in the sector.

Special Grant Report No. 7 (Wales) will seek the National Assembly's approval to allocate £2.8 million in 2004-05 for local authorities to deal with the collection, storage and disposal of domestic refrigeration equipment. The Special Grant Report also allows £0.2 million of grants paid to local authorities to be reallocated for the management of fridges.

- **The National Health Service (Performers Lists) (Wales) (Amendment) Regulations 2005**

The primary purpose of the Regulations is to ensure that any person who is already listed on a performers list (or medical performers list in the case of a GP) in the United Kingdom who applies to be listed on a performers lists held by a Local Health Board (LHBs) will be entitled to make an expedited application and to provide less information than if he or she were applying to be on a performers list for the first time. Once the application is received the applicant will be entitled to practice for a period of two months or until such

time as his or her application is determined by the LHB (whichever is the shorter).

- **The Miscellaneous Food Additives (Amendment) (Wales) Regulations 2005**

The proposed legislation will transpose and implement Commission Directives 2003/95/EC and 2004/45/EC. The new Regulations will amend the Miscellaneous Food Additives Regulations 1995 (as amended) in Wales to implement the fifth and sixth amendments to Commission Directive 96/77/EC, which lays down specific purity criteria for food other than colours and sweeteners throughout the EU. The legislation forms part of a continuing programme to update EU specifications for food additives, which are used to ensure the purity of food additives.

- **Motion to approve The Horse Passports (Wales) Regulations 2005 (30 munud)**

These Regulations provide enforcement authorities with powers to enforce a European Commission Decision in relation to the identification of horses treated with medicines that must not be administered to food producing animals. They revoke and replace the Horse Passports Order 1997 and the Horse Passports (Amendment) Order 1998 in so far as they extend to Wales.

- **Cynnig i Gymeradwyo o dan Reol Sefydlog 24.27 (iv) Rheoliadau Ardrethu Annomestig (Hysbysiadau Galw am Dalu) (Cymru) (Diwygio) 2005 (15 munud)**

The content of Non-Domestic Rating (NDR) demand notices and the explanatory information that accompanies the bills is prescribed in The Non-Domestic Rating (Demand Notices) (Wales) Regulations 1993 and these regulations will amend the 1993 regulations. NDR bills are accompanied by explanatory notes, which explain the various reliefs available to a ratepayer and procedures for appeals. Councils include these notes with the bills and the Assembly prescribes the form of words to be used.

The Local Government Act 2003 contains provisions for Community Amateur Sports Clubs (CASCs) that are registered for the purposes of Schedule 18 of the Finance Act 2002, to receive mandatory rate relief at 80 per cent of their bills. This relief may be increased to 100 per cent at the discretion of local authorities. The provisions came into force on 1 April 2004, and sports clubs must be registered as a CASC with the Inland Revenue in order to receive mandatory relief. An amendment to the regulations will need to be made to include this information in the notes to the bills. Also, the Business Rates Revaluation takes effect in 2005/06, and information on this will need to be included, as well as an update on the appeals procedure.

Standing Order 21.12 requires the Minister for Local Government to lay before the National Assembly the Local Government Finance Report (No.2) for Welsh police authorities for the financial year 2005-06; and the amending report for councils and police authorities for the financial year 2003-04. Both reports are for approval by resolution of the Assembly.

The Chief Medical Officer produces regular reports on the health of the people of Wales. This report is the first in a new series of shorter reports designed to help readers focus more quickly and easily on key issues and information. The reports aim to bring attention to important health issues for Wales and to describe the ways in which they are being tackled. This report sets the scene for all to respond to Health Challenge Wales with a statistical overview of the health of people in Wales and a focus on three key health issues -respiratory disease, sexual health and physical activity. The next two reports in the series will include Accidents and Injuries and Tobacco.
