Huw Lewis: The Welsh Government uses a range of data to assess how the Foundation Phase is being implemented. Theses include teacher assessment and the results on the national reading and numeracy tests as set out below at the end of the Foundation Phase; and Estyn inspection information. In addition, in July 2011 we commissioned an independent evaluation to examine the implementation and impact of the Foundation Phase. The study is being led by the Welsh Institute of Social and Economic Research (WISERD) and is due to end in 2014. The study will analyse data from a combination of surveys (sample of approximately 600), interviews (approximately 300) and classroom observations (approximately 130). Results will be published on the Welsh Government's webpages.

Following preliminary findings from the Evaluation in June 2013, I asked Professor Iram Siraj-Blatchford from the Institute of Education at the University of London to undertake a stocktake of how the Foundation Phase is being implemented in Wales and make recommendations about how it can be strengthened in the future. The stocktake began in September 2013 and will be completed by the end of March 2014.

Results from the National Reading and Numeracy Tests, which start at the end of the Foundation Phase will provide a common source of information for schools in assessing learners' reading and numeracy skills at this crucial early point.

In relation to on-entry assessment to the Foundation Phase, the Welsh Government is currently developing a new assessment tool which can be used to provide a baseline for children when they enter the Foundation Phase and to track their progress through to the end of Phase teacher assessment. The new assessment tool will be rolled out nationally from September 2014 and will bring consistency to these assessment arrangements. In the meantime, a variety of assessment tools are being used by schools and settings to provide a baseline.

Huw Lewis: The model used to calculate bands will be reviewed periodically. This will help ensure it continues to reflect the main priorities for education in Wales, and is responsive to changes in education, for example taking the recommendations of the Review of Qualifications on school performance measures into account.

The methodology has remained the same for the first three years of banding for comparability and consistency, and is due to be reviewed following the publication of the bands in December 2013. Officials from the Welsh Government will work with stakeholders early next year to ensure that the model takes account of the learning needs of all pupils in Wales.

The group will now work closely with Healthcare Inspectorate Wales, devolved administrations, professional bodies and other key stakeholders to implement Sir Bruce Keogh's report.

I have asked the group to keep me informed of their progress.

The Minister for Natural Resources and Food (Alun Davies): The operation of effective markets has been a key priority of Welsh Government discussions and correspondence with the UK Government during the development of the Energy Bill to ensure Welsh consumers receive a fair deal. I have not made any representations to the UK Government specifically on greater regulation of the oil industry. I am exploring what additional action we can take to help households in Wales who are not on the mains gas network and who are dependant upon oil.
