A further £32.2 million was provided to LHBs in 2008-09 to meet an estimated loss of income from the cost of prescriptions. From 2009 - 10 all costs have been met from each LHBs annual allocation and this information has not been routinely recorded.

**Lesley Griffiths:** All health professionals have a statutory duty of care to their patients and this extends to ensuring that safeguarding arrangements are in place to promote the health of and to protect children, young people and vulnerable adults.

Public Health Wales (PHW) provides published guidance to support dental practitioners in meeting the Welsh Government Standards for Health Services. This guidance clarifies the roles and responsibilities of general dental practitioners and the whole dental team in promoting the safety and well being of children, young people and vulnerable adults. Compliance is monitored as part of the annual Dental Reference Service inspection and the Quality Assurance System (QAS) check undertaken by PHW.

**Lesley Griffiths:** The Welsh Government is committed to reducing obesity levels in Wales and encouraging individuals to take a healthy approach to their lifestyle choices, including on diet and physical activity. Inactive obese patients that meet the entry criteria can be referred onto the National Exercise Referral Scheme, which will enable them to exercise under the supervision of specialist qualified exercise instructors, with assessments of their progress at 4 and 16 weeks.

Depending on the severity of their condition they may be advised to access outdoor activity at either of these assessments, or at a later stage. This approach minimises the risk of clients undertaking inappropriate levels of activity too soon. Outdoor activities typically used as part of the National Exercise Referral Scheme are walking, Nordic walking and gardening, and to a lesser extent cycling, as available locally. Following the completion of the programme exercise, professionals signpost participants to these outdoor activities, as appropriate.

**The Minister for Local Government and Communities (Carl Sargeant):** There are a number of actions relating to forced marriage and honour based violence within the 3 year Implementation Plan that supports the Welsh Government's "Right to be Safe" 6 year integrated strategy for tackling all forms of violence against women.

During 2010-11, we provided £48,000 of funding to South Wales Police working in partnership with the Henna Foundation and BAWSO to provide four training courses on dealing with cases of forced marriage which may lead to earlier identification and intervention in cases of forced marriage. In this financial year BAWSO has continued to raise awareness with professionals and frontline staff working in the agencies identified by providing training toolkits for the staff. The toolkit has been funded by Welsh Government. We will continue to work with our UK Government partners in tackling these issues.

**Carl Sargeant:** The Welsh Government is promoting the safety of school transport in a number of ways. In January 2010 we published guidance on Home to School Transport Risk Assessments that provides a tool kit for ensuring the safety of pupils travelling from home to school. The risk assessment covers safe walking routes, pick up and drop off points as well as the school site. At the same time we published the All Wales Travel Behaviour Code that promotes safe travel for all learners by setting out the standards of behaviour required.

In addition the Safety on Learner Transport (Wales) Measure 2011 also encourages the promotion of safety for pupils on school transport and requires seat belts to be provided on all dedicated home to school transport by 2014.
