The Minister for Education and Skills (Leighton Andrews): Local authorities are statutorily responsible for ensuring that appropriate school support is in place for all children with additional needs to ensure they reach their full potential. This includes those pupils on the Autism Spectrum which encapsulates children and young people with Asperger's Syndrome.

The ASD Strategic Action Plan for Wales has achieved much since its launch in April 2008. The first phase of the Action Plan has been to put in place an ASD infrastructure within the statutory services including a local ASD lead in every authority. There has also been an emphasis on training professionals and raising awareness of ASD.

Since 2008 we have provided approximately £9.4 million in direct grant to support the implementation of the ASD Action Plan. This is in addition to a recurrent sum of £1.7 million revenue support grant allocated to local authorities since 2008-09 to support the delivery of services to children with ASD.

At the end of last year we sought the views of stakeholders on the future priorities for the ASD Strategic Action Plan. Using the feedback from the stakeholder events we are drafting a revised ASD Action Plan which will go out to wide consultation later on this year. A refreshed ASD Action Plan will be in place for 2014-15.

Through SEN Reform, we are proposing to replace the statutory framework for the assessment and planning of provision for children and young people with special educational needs (SEN), including those with Autistic Spectrum Disorders (ASD), with a simpler, more person centred system. Our aim is that this will lead to increased trust and confidence of parents and carers in the system, provide greater consistency between schools and local authorities, and foster more effective partnerships between agencies.

One of the key issues central to our proposals is to introduce an Individual Development Plan (IDP) planning process which it is proposed will replace the current statutory assessment process for SEN. Pilot Projects to test the IDP Planning Process and associated web based tool are currently running in eight

authorities across Wales and those with ASD are amongst the cohorts of children and young people being included in the Pilots.

Leighton Andrews: The Education Act 1996 places a duty on local authorities to provide suitable education for all pupils, including those with special educational needs (SEN). The exact nature and provision and how it is organised is a matter entirely for the authority to determine. In discharging these duties, local authorities must have due regard to the SEN Code of Practice (effective from 1 April 2002) which provides practical advice to local authorities, maintained schools, early years settings and others on carrying out their statutory duties to identify, assess and make provision for children's SEN.

The Code of Practice describes how help for children and young people with SEN should be made by a step by step graduated response. This may include bringing in specialists outside of the school, such as an Educational Psychologist, who has a key role in the early years of assessment and intervention and in providing support and advice to parents.

The Code of Practice does not specify a timescale for an Educational Psychologist Assessment. The arrangements for the engagement and allocation of the services of an Educational Psychologist are entirely a matter for the local authority concerned.

Leighton Andrews: Welsh Government officials were alerted on 24th October 2012 to serious issues at Coleg Harlech WEA North which meant that its financial position was circa. £900k weaker than had previously been reported, presenting real risks to the solvency of the institution.

Officials visited the College on November 1st to assist in identifying a course of remedial action, which resulted in agreement with the College Governors for the production and submission of a recovery plan in line with the requirements of the Financial Memorandum between the College and the Welsh Government.

An initial draft of the plan was received just prior to Christmas, with the College Principal indicating that the document was still very much in draft form, particularly in regard to the position after August 2013. Additionally, another course of action, the realisation of assets was being considered. A finalised plan was submitted toward the end of January 2013.

Independent accountants were engaged to evaluate the plan. Their report stated that while realisation of the plan was feasible, its success would be very much dependent on maintaining the principles of strict financial management and control.

Merger discussions between the College and WEA South, which had been suspended during the recent crisis, have been restarted in an attempt to protect the ethos and culture of WEA provision for the future. The success of these discussions will of course be influenced by the outcome of the financial recovery plan.

Leighton Andrews: The College is largely funded by Welsh Government to provide Adult and Community learning delivered via a less formalised setting. Our direct discussions with Coleg Harlech WEA (North) have largely been with members of the Governing body because of their responsibility to maintain the solvency of the institution.

Responsibility for staffing matters rests with the Governing Body and Senior management of the institution. Welsh Government officials have had some, albeit limited, influence on ensuring that communication is properly maintained with staff, via the secondment of managerial support, which was put in place in conjunction with CollegeWales, to temporarily strengthen the senior management function at the college.

Coleg Harlech Governors have been encouraged to communicate developments with staff openly in order to secure consistency in message and to allay rumours and fears, which has at least served to limit misinformation locally.

Resumption of merger discussions with WEA South has demonstrated that staff are ultimately fully supportive of the concept, ethos and culture of an all Wales WEA organisation, continuing to actively engage with the various working groups set up to progress the merger.

Leighton Andrews: During late January 2013 it became apparent that the financial difficulties reported at Coleg Harlech WEA North were having a direct effect on the cash flow of the college. A decision was made by Welsh Government to agree a request from the College governors for an advance of the March recurrent funding allocation, to allow the institution adequate opportunity to achieve recovery.

Welsh Government officials have worked closely with the College on the detail of their financial recovery plan, ensuring that reasonable timescales were set for its submission and achievement.

During this period of uncertainty provision has been maintained, and officials continue to work with the College to ensure that learners are able to undertake their learning and complete their studies with minimal disruption. The focus of Welsh Government involvement throughout has been on safeguarding provision for Coleg Harlech WEA North learners, through agreeing clear timescales for action to ensure learners remain unaffected.

Leighton Andrews: Responsibility for the College rests with its Governing Body and Senior Management Team. The focus of the Welsh Government has been to protect the interests of learners and to safeguard public funding.

The Welsh Government acted quickly however to ensure that decisions about the College's future could be made on the basis of sound evidence when concerns around the capacity of the senior management team at Coleg Harlech WEA North became apparent. This followed the departure, in quick succession, of the Finance Director, the Principal and Chief Accounting Officer (who is on sick leave), and the resignation of the Curriculum Director.

The Welsh Government agreed to support management and leadership cover for the college. Following discussions with CollegesWales, an approach to Grŵp Llandrillo Menai resulted in an agreement to cover the requirement in the short term. The former Principal of Coleg Menai agreed, on a two days a week basis, to stand in as the Accounting Officer until the end of March.

Further support has been given, on a similar basis, by the CEO of WEA South who has assisted the college on curriculum matters, liaising with and supporting CHWEAN provision staff.

Assurances have been sought that the learners are the prime concern in any recovery planning, with the focus kept throughout on safeguarding provision for Coleg Harlech WEA North learners.

The Welsh Government monthly recurrent funding allocation due to CHWEAN in March 2013 was agreed for advance payment in February to help alleviate cash flow concerns.

A further meeting was held with the College governors on 25th March when it was suggested that progress is slowly being achieved toward recovery.

The Minister for Health and Social Services (Mark Drakeford): The Welsh Government expectations for waiting times are unchanged. We expect all patients to be seen within our waiting times target and in order of clinical importance, no matter where they are treated. The target in Wales was agreed with clinicians, and the underlying principle is for patients to receive the care they need within clinically determined timescales. All Health Boards and the Welsh Health Specialised Service Committee are required to work on this basis.
