**Y Dirprwy Weinidog dros Blant (Huw Lewis)**: Flying Start is our flagship early years programme and provides a path towards improving the life chances of children in our most disadvantaged communities. In determining how best to deploy additional resources we have earmarked £2.5million for investment in this important programme. We will be holding discussions with stakeholders in the coming months to set out how this additional investment will be targeted.

Evaluation evidence has shown us that Flying Start is having a real, positive impact on children - when they go to school they are ready to learn, better behaved and more confident at mixing with other children - and we want to ensure that the benefits for these children and their families continue to be maximised.

# Ni ddarparwyd cyfieithiad

I have funded new railway stations on the Ebbw Vale Line and at Abercynon in the last three years.

In 2008, the Ebbw Vale Railway reopened for passenger trains with new stations located at Ebbw Vale Parkway, Llanhilleth, Newbridge, Crosskeys, Risca & Pontymister and Rogerstone. The cost for the 6 stations was £15.5m, at an average cost of £2.6m/each. Of the 6 stations; 4 were single platforms and 2 had twin platforms.

In 2009, the remodelled station at Abercynon opened and this allowed the closure of Abercynon North Station which was on a different site. The Welsh Assembly Government contributed £13.2m to this project which also included the redevelopment of the railway infrastructure and signalling at Abercynon, a two mile passing loop and new platform face at Merthyr Tydfil.

# Ni ddarparwyd cyfieithiad

There are currently 29 arbed projects being delivered across Wales' Regeneration Areas. The £30m investment made by the Welsh Assembly Government has attracted significant additional funding.

There are currently five grantees delivering schemes either partly, or wholly, in the Western Valleys Regeneration area. Grantees are Coastal, Linc, Gwalia and Valleys 2 Coast housing associations and the City & County of Swansea Council. The specific properties and the areas which make up the projects were nominated by these grantees within limits set by the arbed programme.

All these projects are now being delivered. The total investment in the Western Valleys Regeneration Area from the arbed budget was originally set at £5.45m; however the size of investment for all arbed schemes is dependent on projects being able to deliver the measures they originally proposed. Practical issues including the suitability of measures to particular properties or low private sector take-up of measures impact on the final investment made to individual projects. Current investment in the Western Valleys Regeneration Area is £4.85m plus leveraged funding.

Measures being delivered in these projects include solid wall insulation, solar hot water panels, solar photovoltaic panels and air source heat pumps. Wales based businesses (businesses based solely in Wales and those which have a large employment base in Wales) are represented across these technologies and across the supply chain including product manufacture, system installations and scheme management

A clear indication of the outcomes including the number of homes helped, supply chain support and the amount of combined arbed and leveraged funding will be available after the project delivery date of March 31st.

# Ni ddarparwyd cyfieithiad

We are strengthening the range of Child and Adolescent Mental Health Services (CAMHS). The CAMHS financial commitment supports a range of actions, including the development of CAMHS learning disability services. Since 2008 we have invested an extra £6.9m in CAMHS services and £8m in a school-based counselling service.

In June 2010, we launched "Breaking the Barriers: Meeting the Challenges" to improve CAMHS provision. The action plan includes a specific commitment on CAMHS and learning disabilities. We have established a multiagency Delivery Assurance Group, to oversee the implementation of the action plan, which first met in January and I will report on progress against the plan in September.

I am currently considering ways to evaluate and survey existing good practices, training, support and resources in the remainder of the 2010/11 period.
