'(1) Duty to review the Measure

- (1) The Welsh Ministers must at the end of the first complete financial year following the coming into force of this Measure in its entirety –
 - (a) review the operation of this Measure and any regulations made under it or in pursuance of any other enactment in connection with this Measure.
 - (b) publish a report containing an assessment of the impact of any provisions of this Measure including (but not limited to) impact on the financial and other resources of local mental health providers, mental health service providers, care coordinators and independent mental health advocates;
 - (c) lay a copy of the report before the National Assembly for Wales.
- (2) "Financial year" means the period of 12 months ending on 31 March.'

- (1) Rhaid i Weinidogion Cymru ar ddiwedd y flwyddyn ariannol gyflawn gyntaf ar ôl i'r Mesur hwn ddod i rym yn ei gyfanrwydd –
