Thank you for your recent question concerning Welsh Government action to increase nursery staff numbers (Written Question reference WQ87883).

The last few years have proved very challenging with the childcare and playwork sector experiencing ongoing recruitment issues. I am committed to supporting the sector to help address and alleviate some of the pressures they are experiencing.

The Welsh Government's ambition is for a skilled childcare and play workforce that is regarded as a career of choice. We work with sector partners to promote and support the workforce.

We provide funding to Social Care Wales to undertake a variety of activities to support recruitment and retention across the sector. This has recently included a pilot introductory course to support recruitment into the sector, and the "WeCare Wales" recruitment campaigns and a jobs portal, to attract people with the right skills and behaviours into the sector. At the moment, a TV and radio marketing campaign to support recruitment and showcase the childcare and play sector is running on various platforms and channels across Wales.

Cross governmental work is also a crucial factor in supporting recruitment to the sector via a wide variety of programmes. This includes support available from national employability programmes such as <u>ReAct+</u>, <u>Business Wales</u> and <u>apprenticeships</u>, all of which encourage and support individuals to join the workforce.

Working Wales also ran a focused spotlight campaign on childcare careers and routes into the sector during the week of 9 January 2023 and further campaigns will take place at
