The Minister for Health and Social Services (Lesley Griffiths): I recognise sickness absence has a significant impact in Wales and at the UK level the major causes of working days lost due to self-reported work-related illnesses are musculoskeletal disorders, stress, depression and anxiety.

Musculoskeletal disorders have consistently been one of the most common self-reported type of workrelated illness. Figures published by the Health and Safety Executive show that in 2009/10, there was a total of 9.3 million working days lost due to work-related musculoskeletal disorders in the UK, which equates to 0.4 days per worker. The average length of absence for a musculoskeletal disorder was 16.3 days.

Detailed data relating to the number of lost working days due to musculoskeletal disorders, rheumatoid arthritis, Crohn's disease, and psoriasis in Wales are not readily available. The Health and Safety Executive publish the figures for working days lost on their website. http://www.hse.gov.uk/statistics/dayslost.htm

**Lesley Griffiths:** Musculoskeletal disorders, including back pain and arthritis, are one of the most common cause of sickness absence from work, and the Welsh Government's Healthy Working Wales programme provides a range of advice and support to employers, employees and health professionals to improve health at work; to reduce the impact of ill health at work; and to encourage early intervention for those who are made ill at work (www.healthyworkingwales.com).

Healthy Working Wales provides free access to advice from an occupational health nurse for employees with musculoskeletal disorders and for employers who are managing staff with these conditions, through the Health at Work Advice Line Wales. In addition, the Healthy Working Wales website has recently been piloting a new service to help line managers to support their staff with a health condition. This includes specific advice in relation to musculoskeletal disorders and arthritis; it will be launched later this year.

**Lesley Griffiths:** Improving the health and well being of NHS staff is one of my key priorities and I have set targets in the Annual Quality Framework for all NHS organisations to achieve a Platinum Corporate Health Standard Award by March 2013. The Corporate Health Standard provides support and recognition to employers to improve the health and well being of their staff. It encourages organisations to target the key issues which impact on their staff, and NHS Wales has reported that musculoskeletal disorders account for 28% of total absence. I therefore would expect all NHS organisations to be tackling musculoskeletal disorders, which includes arthritis, as a priority.

As part of this engagement with the Corporate Health Standard, all NHS organisations are part of our Healthy Working Wales network and have access to information and advice as outlined in my response to WAQ58193.

In addition to this work, all NHS Wales organisations have been set sickness absence improvement targets and key health and safety performance indicators for health and safety are included in Annual Quality Framework. These indicators are agreed on an annual basis with the Health and Safety Executive, to ensure that they reflect the key issues affecting NHS Wales and its staff.
