### ***Gofyn i'r Gweinidog dros yr Economi a Thrafnidiaeth***

**Andrew RT Davies (Canol De Cymru):** A wnaiff y Gweinidog gadarnhau sawl datganiad o ddi-ddordeb a gafodd yn y Parc Busnes Aerofod yn Sain Tathan gan ddarpar fuddsoddwyr a faint o bosibiliadau y mae'n eu datblygu ar hyn o bryd. (WAQ56882)

#### ***Ni ddarparwyd cyfieithiad***

Since November 2008, there have been ten expressions of interest from aerospace related businesses in the facilities at St Athan, of which eight are live inquiries.

**Andrew RT Davies (Canol De Cymru):** A wnaiff y Gweinidog gadarnhau pa lefel o integreiddio, os o gwbl, a ragwelwyd rhwng y Parc Busnes Aerofod a'r Academi Hyfforddiant Amddiffyn yn Sain Tathan, yn benodol, gan gyfeirio at unrhyw ddatblygiad seilwaith o'r Parc Busnes Aerofod a oedd yn dibynnu ar sefydlu'r Academi Hyfforddiant Amddiffyn. #### ***Ni ddarparwyd cyfieithiad***

We have taken a comprehensive and co-ordinated approach to the development proposals for St Athan regarding them as complementary, but separate, aspects of a single scheme for the successful redevelopment of the whole site. Synergies between the two proposals exist in the form of promoting aeronautical engineering training and opportunities for transferable skills between civilian and military roles, and a joint approach to habitat management.

Plans for the redevelopment of the existing aerospace site at St Athan envisage a phased development over a twenty year timeframe, subject to market demand. Full planning applications will be submitted as and when potential clients confirm any investment plans at St Athan.

It is envisaged that private investors and development companies will work with the Welsh Assembly Government to redevelop the business park either for direct occupation or as an investment opportunity. We anticipate that private sector funding and expertise will be used to regenerate the estate and to have a key role in the operation and managements of the airfield as the site is developed fully.
