On 23 February, I promised that I would ask the Chief Executive of Cardiff Bay Development Corporation to provide detailed responses to four of your Written Assembly Questions. WAQ 3687, 3688, 3689 and 3693. Three of the four of his responses are as follows

WAQ3687

What safety regulations are necessary for the running of the Cardiff Bay Barrage?

The safety regulations which apply to the barrage include:-

The Construction Design and Management Regulations 1994

The Health and Safety at Work Act 1974

The Management of Health and Safety and Work Regulations 1992

The Provision and Use of Work Equipment Regulations 1992

The Corporation confirms that it has carried out a risk assessment with regard to operation of the Barrage and a fire risk assessment for all the Barrage Structures. It is also confirmed that both the Corporation and the Barrage operators are working in accordance with the above statutes and regulations.

The Barrage structure is not at present open to the public. Before this is allowed to happen, it is the Corporation's intention to receive approvals from both the Health And Safety Executive and the RoSPA.

How much training is necessary in order to comply with safety regulations in the running of Cardiff Bay Barrage?

Barrage staff are required to comply with more than safety regulations: they must demonstrate a standard of competence and overall understanding of the obligations required by the Barrage Act and Legal Agreements; Operations Policy and Procedures Manuals and the Operation and Maintenance Manuals.

The Corporation's view is that to train a team of staff it would take six months provided they were helped by managerial staff from the Corporation and Crest Nicholson.

What will be the total amount of monies and responsibilities, at the lowest possible breakdown, that Cardiff County Council will inherit from Cardiff Bay Development Corporation and the National Assembly for Wales on April the 1st?

An analysis was provided by the Assembly Secretariat to the Economic Development Committee on 1 March. Additionally the Corporation is contributing, by way of discount, £2m for "social purposes" at Ferry Road.

The response to the further question (WAQ 3689), about the cost of management and maintenance of the bay, is being dealt with by the Corporation, and I will provide you with an answer as soon as it is available.
