The Minister for Health and Social Services (Lesley Griffiths): The NHS is under a statutory duty to fund All Wales Medicines Strategy Group (AWMSG) and NICE approved medicines, where a patient's clinician thinks they are the most appropriate treatment option (and the patient meets the relevant clinical criteria). The All Wales Therapeutics and Toxicology Centre are currently undertaking a review of the uptake of new technologies appraised by AWMSG and NICE. This report will be available in late November.

The Deputy Minister for Children and Social Services (Gwenda Thomas): The Child Sex Offenders Disclosure Scheme is non-devolved. Information on the scheme for parents, guardians and carers and how they can ask the police if someone has a record for child sexual offences is available from the Home Office website. My officials will keep in touch with the Home Office as they consider the ruling handed down following a Judicial Review of the scheme.

The Welsh Government has published Safeguarding Children: Working Together under the Children Act 2004 that sets out how local authorities and other agencies must cooperate to safeguard and promote the welfare of children in Wales. My written statement of 18 October set out how we will use the forthcoming Social Services and Well-being (Wales) Bill to strengthen safeguarding and protection arrangements.
