The Minister for Education and Skills (Leighton Andrews): The Revenue Support Grant (RSG) provides unhypothecated funding, including for Education, to local authorities. The distribution of the RSG is based on a number of indicators including pupil numbers at a local authority level. There is no particular indicator used in the distribution formula which reflects the issue of language.

Once the RSG has been distributed to local authorities, it is the responsibility of each individual authority to set budgets for their schools. These are determined by a local funding formula, operating within the framework set by the School Funding (Wales) Regulations 2010. In accordance with the regulatory framework, local authorities may take into account in their funding formula whether a pupil is being educated through the medium of Welsh.

The Regulations require 70% of funding for schools' budgets to be distributed on the basis of pupil numbers and local authorities have discretion to distribute the remaining 30% on the basis of a range of factors, including the Welsh language. Further information on these additional factors can be found under regulation 18, Schedule 3 of the School Funding (Wales) Regulations 2010, which can be accessed from the following link: http://www.legislation.gov.uk/wsi/2010/824/contents/made.

The Welsh Government recognises there are additional costs to providing education through the medium of Welsh. For example, there may be additional costs because there are fewer off the shelf learning resources or because pupils may require more intensive language tuition if Welsh is their second language. Each local authority will be required to prepare and submit a Welsh in Education Strategic Plan under the provisions of the School Standards and Organisation Act demonstrating they are providing appropriate resources as an essential part of effective planning for Welsh medium education.

In terms of expenditure, the delegated school revenue outturn expenditure for 2011-12, by sector and by English and Welsh medium schools is enclosed below. It is important to note that comparing funding and expenditure on a per pupil basis can be a crude measure. It does not necessarily provide an accurate representation of the levels of support an authority makes available to each school. Neither does it isolate language medium from the broad range of additional factors which local authorities take into account in determining school budgets, including small schools protection, additional learning needs, different premises running costs and so on. Rather, the average per pupil funding figure is a statistical tool to help aid understanding of authorities' relative spend on education overall.

Leighton Andrews: Home to school transport is a matter for the Minister for Economy, Science and Transport. My expectations around the provision of home to school transport for pupils receiving faith based education is no different to that of other pupils.

Under the Learner Travel (Wales) Measure 2008, essentially, the provision of free home to school transport to denominational schools is a discretionary matter for local authorities and the Welsh Government does not intervene. If a learner is of compulsory school age and wishes to attend a faith-based school which is the nearest suitable school and also meets the relevant distance criteria for their age, then the local authority will be under a duty to provide free home to school transport. Where the

criteria set out above are not met, the provision of free transport to faith-based schools is a discretionary matter for local authorities.

Leighton Andrews: The consultation on the draft Healthy Eating in Schools (Nutritional Standards and Requirements) (Wales) Regulations closed on 25 April, and responses are currently being considered.

The draft regulations are based on the Appetite for Life food and nutritional standards which local authorities and schools have been working towards since 2008.

The finalised regulations will be made under section 4 of the Healthy Eating in Schools (Wales) Measure 2009 and apply to local authorities and governing bodies of maintained schools that provide food and drink to pupils of maintained schools whether they are on school premises or not, and to other persons on school premises. They will set out the types of food and drink that can, or cannot, be provided during the school day and define the nutrient content of school lunches. I propose to bring section 4 and the other provisions of the Measure into force during 2013.

Leighton Andrews: With the first year of the PDG only just completed, it is too early for any meaningful, in-depth analysis of its effectiveness to have taken place. I am, of course, very anxious to know as soon as possible how effectively the PDG is being implemented in practice and where

improvements can be made in implementation, management and governance. With that in mind, following a recent competitive tender exercise, Ipsos Mori, in collaboration with Cardiff University based WISERD, has been commissioned by the Welsh Government to undertake an in-depth evaluation of the effectiveness of the Pupil Deprivation Grant (PDG).

The evaluation will focus specifically both on how the PDG is being interpreted and implemented in practice and what impact it is having on pupils' performance and on practice within schools.

I am expecting the evaluation reports to identify potentially productive best practice which can be shared with local authorities and schools across Wales. I would also expect the evaluation to inform monitoring arrangements, including the possibility of broadening Estyn's school inspection remit to include monitoring the use and effectiveness of the PDG.

In addition, as part of their annual remit, Estyn has undertaken a number of pieces of work looking at how schools in Wales are tackling child poverty to improve learners' achievement and wellbeing.

The Commissioner is independent of Government and therefore cannot be directly involved in the process of drafting the Strategy for Older People. The Commissioner and her staff have, however, been involved from the outset in the development of our ambition for the next 10 years of the Strategy for Older People. The Commissioner has shared the intelligence that she has received directly from older people with the Deputy Minister and our officials which has helped shape our analysis and decisions about the next phase.

There has been a productive dialogue through regular meetings between the Commissioner and our officials during the drafting of Phase 3. In addition the Commissioner provided a detailed written consultation response to our proposals for Phase 3, which have been reflected in the new Strategy document. The Commissioner has a clear role in scrutinising implementation of the Strategy and I am confident we share the same ambition of making Wales a great place to grow old.
