To propose that the National Assembly for Wales, acting under Standing Order 31.2:

1. Supports in principle legislation to commence Section 175 of the Education Act 2002 (duties of LEAs and governing bodies in relation to the welfare of children) in Wales; and

2. Agrees that any guidance issued under Section 175(4) should include matters such as the nomination of a named governor responsible for child protection matters and the setting up of a LEA database of nominated governors.

A statement of legal powers under which the proposed legislation could be made and an indication of the resource implications and other material in amplification of the proposal is as follows:

Statement of Legal Powers

Section 216(4) of the Education Act 2002 confers upon the National Assembly power to commence provisions of the 2002 Act in relation to Wales.

Resource Implications

Currently Section 175 of the Education Act 2002 is not commenced in Wales, having been commenced in England in June 2004. This requirement will not need increased remuneration and discharge of these duties will be carried out under current budgetary arrangements. Any expenditure incurred will be negligible.

Add new point at end of motion:

Notes that if the EU budget is reduced to a maximum of 1% of GDP, Wales would be highly unlikely to qualify for Objective One funding and as a direct consequence would not qualify

as an art.87(3)a area.

2. Jocelyn Davies (South Wales East)

Add new point at end of motion:

Joins with the other regions and local government areas of the European Union in their opposition to the UK government's efforts to reduce budget contributions to a maximum of 1% of GDP.

3. David Melding (South Wales Central)

Add new point at end of motion:

Calls upon the Welsh Assembly Government to urge the UK Government to negotiate with the European Commission to allow deprived wards, that are not adjacent to an Article 87(3)(C) or a Statistical Effect area, to be designated as an Article 87(3)(C) area.
