The Youth Justice Board for England and Wales is responsible for commissioning secure accommodation and placing young people under 18 remanded or sentenced to custody in secure accommodation. The provision of educational services is part of this commissioning process and therefore monitoring of performance is a contractual matter for the Youth Justice Board.

Ken Skates: This is primarily a matter for the Youth Justice Board for those under 18. Earlier in the year the Welsh Government responded to the Ministry of Justice consultation "Transforming Youth Custody: putting education at the heart of detention". In this response Welsh Ministers stressed the importance of taking a holistic approach to a young person's needs and highlighted the importance of literacy and numeracy skills.

Critical to sustained engagement in learning, the development of employability skills and positive progressions into employment is the strengthening of the links between devolved and non devolved services. The Minister for Local Government and Government Business announced on the 9th October 2013 that the Welsh Government is to introduce a youth justice bill. The legislation will aim to prevent children and young people from reoffending and progressing through the system into custody; provide better support for those young people who are sentenced to custody; and create multi-agency resettlement partnerships to ensure better support when they leave custody.

Ken Skates: Young people under 18 generally spend only a relatively short period in custody; three to four months being the average sentence. There is thus limited opportunity to compete full courses of learning.

The commissioning of services for those under 18 in young offending institutions is the responsibility of the Youth Justice Board. Research on effective practice, which includes the challenges faced by young people, can be found on their web site http://www.justice.gov.uk/about/yjb.

Recently I have visited the Oyster Catcher Restaurant and Chef's Academy on Anglesey. I talked to young people and adults with an offending background and learnt of their experiences and the challenges they faced.

The Welsh Government has a Section 83 agreement in place with the National Offender Management Service (NOMS) for learning and skills in adult custodial establishments. For individuals who are aged 18-21 and serving their sentences in an adult custodial establishment, Welsh Government officials meet regularly with National Offender Management Services' (NOMS) officials under the remit of this agreement.

The learning and skills needs for offenders aged 18-21 serving their sentence in adult custodial establishments are assessed at the beginning of their sentence via the induction process. Offenders are assessed to determine their literacy and numeracy skills and any learning difficulties or disabilities. An individual learning plan is completed which outlines the learning they will undertake whilst in custody and their overall learning and employment goals together with any prior achievements.

Derbyniwyd ateb i'w gyhoeddi ar 13 Tachwedd 2013 Answer received for publication on 13 November 2013 The Minister for Health and Social Services (Mark Drakeford): The recently launched Diabetes Delivery Plan reconfirmed the Government's commitment to the delivery of the Diabetes National Service Framework for Diabetes in Wales (NSF) and includes a requirement on Health Boards to report on its delivery as part of the Plan's reporting structure. This will include the implementation of Standard 5 of the NSF, which covers appropriate access to psychological and/or counselling services including those for children. To reflect the Government's transparency agenda, these reports will be published on Health Boards' web pages and form part of the Welsh Government's annual progress report.

The NHS Wales Diabetes Implementation Group has been established to provide strategic leadership and support to Health Boards in their delivery of the Diabetes Delivery Plan. It has a specific work stream for paediatric diabetes. This work stream may wish to prioritise the provision of psychological services as part of their work if they consider current provision inadequate. My officials will raise this with them.

Mark Drakeford: All organisations are required to demonstrate they are meeting the Standards for Health Services in Wales, Doing Well, Doing Better. Standard 7 sets out the need to ensure that patients and service users are provided with safe, effective treatment and care based on agreed best practice and guidelines including those defined by NICE. All organisations complete an annual self assessment against compliance with standards.

The Welsh Government's focus is on improving outcomes across a range of conditions through 'Delivery Plans. The draft Neurological Conditions Delivery Plan was published for consultation at the end of last month. This reinforces the role of national guidelines such as NICE guidance and the Service and Commissioning Directive, and the Welsh Government's expectations of effective care of people with a neurological condition The Epilepsy Service Development and Commissioning Directive was published in 2009; the latest NICE guidelines were published in 2012. Health Boards are expected to provide services in line with the most up to date evidence based best practice wherever the source of that advice.

As part of the implementation of the Delivery Plan we will be looking at several key assurance measures to monitor overall progress rather than monitoring specific pieces of guidance.

The Deputy Minister for Social Services (Gwenda Thomas): The refreshed Carers Strategy for Wales, published in June 2013, sets out the actions we are taking to improve support for young carers in Wales. Young carers remain one of the five key priority areas within the Carers Strategy. In developing this Strategy we have listened directly to the concerns and issues which have been raised by the Wales Young Carers Network.

One of the main concerns was the level of recognition young carers receive from professionals within the health, social services and education sectors. Our new on-line toolkit for professionals (http://youngcarerstoolkit.co.uk/) and the awareness raising activities being undertaken by Local Health Boards and local authority partners, as part of their Carers Information and Consultation Strategies, will help with this. We have also commissioned Children in Wales to undertake a study of young carer ID cards and produce guidelines for local authorities who wish to set up such schemes. Mark Drakeford: The Putting Things Right arrangements set out clear requirements to ensure a consistent approach to the management of complaints and concerns. In addition, the Welsh Government is working with NHS organisations to finalise a revised statistical return on 'concerns' in line with the requirements set out in the regulations.

We will be holding an annual pan Wales workshop early in the New Year to share best practice on all aspects of concerns handling. This will bring together the findings from the annual NHS Welsh Risk Pool Services' assessment, feedback from the Community Health Council advocacy service and the Public Services Ombudsman for Wales.
