### ***Gofyn i'r Gweinidog dros Blant, Addysg a Dysgu Gydol Oes***

#### ***Ni ddarparwyd cyfieithiad***

Discussions took place in 2008 with the UK Government on participation in the ESLC. Wales decided to focus resources on broader international surveys of skills such as PISA (Programme for International Student Assessment). The value of the ESLC is considered to be limited by two factors: lack of eligibility to include the assessment of Welsh as one of the two compulsory languages taught; and omissions in participation by key Member States such as Germany and Italy, and the UK's participation being represented by England only.

We are keen however, to consider the survey results to be published in early 2012, as well as any lessons for Modern Foreign Language policy and delivery in Wales.

The Welsh Assembly Government's commitment to improve opportunities to learn a foreign language is set out in the action plan, Making Languages Count, published in July 2010.

#### ***Ni ddarparwyd cyfieithiad***

The Welsh Assembly Government has promoted and delivered an on-going campaign to raise awareness of business opportunities associated with the Olympic Games to help companies maximise those opportunities, including joint events with the Olympic Delivery Authority (ODA) in Wales and visits to the Olympic Park for potential suppliers.

Officials are ramping up engagement with Welsh businesses on the estimated £700m of remaining contracts set to be awarded to businesses in the run up to 2012. Activities will include:

- o tendering events with businesses from Wales; to be held on 1 and 3 February 2011 in Swansea and Mold, and
- o joint events with project sponsors BT, Deloitte and Lloyds TSB in Cardiff on 8 March 2011 and at Llandudno - date to be confirmed.

We will continue to work with the ODA and the London Organising Committee of the Olympic Games and Paralympic Games to identify opportunities for Welsh businesses.

#### ***Ni ddarparwyd cyfieithiad***

Based on information released by the London Organising Committee of the Olympic Games and Paralympic Games (LOCOG), the value of tier one contracts awarded directly by the Olympic Delivery Authority to Welsh businesses is currently valued at £668,403. It is difficult to accurately assess the value of the contracts as a number are subject to commercial confidentiality and not fully declared within overall figures. We continue to work with the Olympic Delivery Authority and LOCOG to fully assess the value and benefits of contracts related to the 2012 London Olympics enjoyed by Welsh firms.

### ***Ni ddarparwyd cyfieithiad***

To date, we have attracted four countries to Wales that have signed a Memorandum of Understanding with the Welsh Assembly Government outlining their intentions to train in Wales. Multi-sport Paralympic teams from Australia, New Zealand and South Africa will carry out their immediate pre Games training in Wales. Australia and South Africa will base its team in Cardiff and Newport whilst New Zealand will be based in Swansea. The Trinidad and Tobago Olympic Committee has also committed to basing its team in Cardiff, along with the Amateur International Amateur Boxing Association 'Road to London' training camp.

The highly successful British Olympic and Paralympic Cycling teams will be based at the Newport velodrome which will be running at maximum capacity before the Olympic and Paralympic Games. The Irish Triathlon team will be based at the world class facilities at Swansea University and the surrounding Gower Peninsular.

In total to date, it is anticipated that camps will involve over 700 athletes and support staff who will train in Wales in the lead in to the Games with a direct investment into the economy running into millions of pounds and will provide the opportunity to develop sporting, cultural and social legacy opportunities for Wales.

The Welsh Assembly Government and partners have hosted National Olympic Committee visits from the following countries that have yet to decide where they will be based in the UK in the lead in to 2012:

Australia (Athletics), Belarus, Botswana, China (Boxing), India, Indonesia, Ireland, Papua New Guinea, Russia, Slovakia

Other nations who have expressed an interest in undertaking recce/fact finding visits to Wales in the near future include Brazil, Israel and Mexico..

Breeding ewe numbers in Wales at June 2010 stood at 4,110,000, 2.9% higher than in June 2009. Female cattle numbers aged 2 years or older stood at 516,000 compared to a June 2009 figure of 511,000. Dairy and non-dairy breeds combined, were also up slightly in June 2010 compared with the June 2009 figure. Although the numbers in fact show an increase rather than decrease, it is too early to say whether this reversal in the decline of breeding livestock numbers will continue. (Source: Defra).

It is too early to report what effect the FSA meat hygiene charging changes will have on the processing capacity within Wales. We must wait for the outcome of the FSA consultation and I shall be formally responding to that consultation.

I will ensure that the FSA remains aware of its statutory obligations to consider the interests of businesses with a low throughput, and the action incumbent on it in the Welsh Assembly Government Food, Farming and Countryside strategy to work with us and Hybu Cig Cymru to devise a charging regime that is fair for small abattoirs.

Its main objective is to seek to reduce the administrative burden on farmers and to offer suitable explanations where a continuing element of procedure is deemed necessary or desirable.
