### Planning Appeals in Hand, and When They are Likely to be Determined

30 JUNE

The attached lists show the cases in hand as at 31-March 2000. They are listed by their unique six/seven-digit number, which broadly correlates with the date received. It also gives the appellant's name and local planning authority, the procedure (where confirmed), the estimated determination time and other details.

#### Jurisdiction

The first list shows cases that are to be determined by the Assembly, and the second, those determined by Inspectors. The vast majority of cases are determined by Inspectors, however some are recovered from Inspectors for the Assembly to determine usually because of the scale or importance of the proposed development.

#### **Procedure**

Except in some of the newer cases and some of those in abeyance, it is possible to state whether the appeal is to proceed by way of the written procedure, a hearing, or a public local inquiry. Where this is possible it has been included.

#### **Estimated Determination**

The month given in this column is based either on our expectations based on a date that has been fixed for a site visit, hearing or inquiry or, where this has not been fixed, the timeliness target for the appropriate procedure.

#### Other Details

This column of the table includes any other details of major importance. These include cases where they are proceeding jointly with another case: for example planning appeals linked to enforcement and lawful development appeals, which take the lead and follow timetables different from those used for planning appeals proceeding on their own.

Environmental Impact Assessment (EIA) cases have also been included. This is where an appeal comes under the appropriate schedules of the Environmental Impact Assessment Regulations. Under these, certain types of cases require an assessment to be carried out and this in turn is assessed for its adequacy: this can cause the appeal process to be extended.

Abeyances are normally only agreed in cases where both the appellant and the local planning authority give their consent. An abeyance request should also show that there is a possibility of an appeal being withdrawn: this is often the result of actions such as fresh applications being submitted to a Council, which overcome the planning objections to the proposal.

#### General

The Planning Inspectorate has been set timeliness targets for planning appeals determined by Inspectors. Under these, 80% of written cases should be decided within 17 weeks, 80% of hearing cases should be decided within 22 weeks, and 80% of inquiry cases should be decided within 30 weeks.
