**The Minister for Finance and Leader of the House (Jane Hutt):** The value for money study into the Welsh Government's relationship with AWEMA was requested by the Welsh Government which has cooperated fully with the Wales Audit Office throughout its preparation. The Welsh Government has welcomed the report and has accepted all of the recommendations.

The Permanent Secretary and Accounting Officer, Derek Jones, outlined on 18 October, that the recommendations and lessons to be learned are being taken forward by work which is already underway to improve the management of grants across the Welsh Government.

The report makes clear that there is no evidence that Ministers exerted any inappropriate political influence over funding decisions and that Ministers always acted in accordance with advice from officials. It also recognises the swift and robust action taken by the Welsh Government when issues emerged in 2011 and the effort that was made to protect those who were participating in projects delivered by AWEMA.
