The Welsh Government's anti-bullying guidance is one of a number of materials which schools may use to develop and implement measures to tackle bullying.

It is the role of Estyn, as part of its inspection programme, to evaluate the arrangements schools have in place for dealing with bullying, and how well schools promote the prevention and elimination of oppressive behaviour, including bullying.

The Minister for Environment and Sustainable Development (John Griffiths): The results of the Rural Enterprise Dwelling Monitoring Exercise, for the period July 2010 to March 2011, will be published to the Welsh Government's Planning Division web site later this month.

My officials will be writing to all local planning authorities shortly to reiterate the importance of the requirements set out in Technical Advice Note 6 Planning for Sustainable Rural Communities. The letter will emphasise that returns for the period April 2011 to March 2012, including nil returns, must be submitted by 31 May. The results of the second monitoring exercise will be published to the Welsh Governments web site during the summer.
