Bydd y sefyllfa hon yn codi ym mhob Cyngor yng Nghymru ar 31 Mawrth 2000. Penderfynir ar y cyfnodau y bydd aelodau sydd wedi'u penodi i'r Cynghorau yn eu swyddi o ganlyniad i'r digwyddiad hwn fel		These Regulations have effect to amend the Community Health Councils Regulations 1996 ("the 1996 Regulations") by providing that regulation 3(2) of the 1996 Regulations shall apply in the event of the terms of office of every member of a Council terminating on the same date which situation will arise in the case of all Councils in Wales on 31 <sup>st</sup> March 2000. The terms of office of members appointed to Councils in consequence of this event shall be settled as if they were on first appointment upon the

The National Assembly for Wales makes the following Regulations in exercise of the powers conferred on the Secretary of State for Wales by sections 126(4), 128 (1) and paragraph 2(a) of Schedule 7 to the National Health Service Act 1977 <sup>(a)</sup> and of all other powers enabling the Secretary of State in that behalf and now vested in the National Assembly for Wales <sup>(b)</sup> ;

1. -(1) Enw'r Rheoliadau hyn yw Rheoliadau Cyngorau Iechyd Cymuned Diwygio (Cymru) 2000 a deuant i rym ar 1 Mawrth 2000.	1.-(1) These Regulations may be cited as the Community Health Councils Amendment (Wales) Regulations 2000 and shall come into force on 1 <sup>st</sup> March 2000.
(2) Yn y Rheoliadau hyn ystyr "Rheoliadau 1996" yw Rheoliadau Cyngorau Iechyd Cymuned 1996 <sup>(c)</sup> .	(2) In these Regulations "the 1996 Regulations" means the Community Health Councils Regulations 1996 <sup>(c)</sup> .
(3) I Gymru'n unig mae'r Rheoliadau hyn yn gymwys.	(3) These Regulations shall apply to Wales only.
<b>Diwygio Rheoliadau 1996</b>	<b>Amendment of the 1996 Regulations</b>

**2.-** Yn rheoliad 3 o Reoliadau 1996, ar ôl paragraff (2) mewnosodir y paragraff canlynol –

"(2A) In the event of the term of office of every member of a Council whose district is situated in Wales expiring on the same date, the term of office of all members appointed in consequence thereof shall be settled in accordance with the same provisions as are applied by paragraph (2) above in relation to first appointments.".

**2.** In regulation 3 of the 1996 Regulations after paragraph (2) there shall be inserted the following paragraph-

"(2A) In the event of the term of office of every member of a Council whose district is situated in Wales expiring on the same date, the term of office of all members appointed in consequence thereof shall be settled in accordance with the same provisions as are applied by paragraph (2) above in relation to first appointments.".
