I have provided funding of £32 million within the local government settlement in Wales to enable local authorities to implement a council tax freeze. Providing the funding within the settlement will allow councils to freeze their council tax if they so choose providing they can reconcile this with the need to sustain services and without prejudicing the protection we are providing for schools and social care funding. The choice is theirs. It will be for each local authority to justify their decision on this issue to their citizens.

Currently council tax levels in Wales are on average 22% lower than those in England.
