The Chair wished the Deputy Presiding Officer well at the imminent CPA Canadian Regional Conference, hosted by the National Assembly for Quebec.

Our participation would provide the first known occasion for Wales to be represented at a CPA Canada Regional Conference. David Rees MS noted that he was looking forward to the conference, which would include a significant audience of over a 100 parliamentarians representing all but one of Canada's 13 Provinces and Territories as well as the networking opportunities that this would provide.
