Under the current phase of arbed, Linc Cymru Housing Association is refurbishing a small number of properties within the Aberavon constituency. The properties in Croeserw and Glyncorwg are cross tenure receiving measures such as solid wall insulation and solar hot water panels.

Arbed Phase 2 will draw on ERDF funds to extend the programme over a period of 3-5 years, building on lessons learned during Phase 1. The business case for this extension is currently being developed with WEFO, and will be finalised during spring 2010.
