**The Minister for Environment and Sustainable Development (John Griffiths):** The general financial duties that will apply to the new body under Article 13 are modelled on those that currently apply to the Environment Agency as laid out in Section 44 of the Environment Act 1995.

The wording of this section is very similar to Section 44 of the Environment Act 1995, signaling that there are no significant changes proposed to the current arrangements.
