- (1) The Learner Travel (Wales) Measure 2008 (nawm2) is amended in accordance with this section.
- (2) After subsection (9) of section 3 of that Measure, insert -
 - "(10) For the purposes of this section a school, unit or institution is not to be considered suitable if it does not deliver the choice of course or courses of

study made by the pupil under the Learning and Skills (Wales) Measure 2009."

- (3) In section 5(a), after 'institution,' insert "other than to enable the learners to complete their choice of course or courses of study under the Learning and Skills (Wales) Measure 2009,"
- (4) After subsection (3) of section 7, insert -
 - "(4) Regulations under this section must be made before the coming into force of Part 2 of the Learning and Skills (Wales) Measure 2009.".
