The Minister for Business, Enterprise, Technology and Science (Edwina Hart): Following discussions with the University of Wales, funding for the scheme is being scaled back. WEFO will continue to honour existing contractual funding commitments to the scheme in respect of eligible scholars and businesses, subject to assurances regarding the quality of academic support and supervision being forthcoming. Following this, the EU funded project will close.

Finally, the concept of recruiting the best graduate talent to boost innovation among businesses in Wales has much to commend it. Officials in my department are currently considering options for delivering an alternative scheme to that offered through the POWIS project and I will keep Members advised.

The Minister for Education and Skills (Leighton Andrews): At the time of its introduction it was widely acknowledged that the Healthy Eating in Schools (Wales) Measure gave a further legislative foundation to an approach that the Welsh Government were already taking forward via Appetite for Life – our agenda for improving food and drink provided in schools. Our primary school free breakfast initiative and the school milk scheme are also an integral part of our food in schools agenda.

The total indicative provision within our food in schools budget for 2012-13 is £17.85m. This includes £2.4m to continue to help schools and local authorities to move towards the Appetite for Life food and nutritional standards. Funding to support schools and local authorities in moving to these more challenging food and nutritional standards has been made available since 2008-09.

The provisions in the Measure will become statutory in primary schools from September 2012 and in secondary schools and special schools from September 2013.
