Thank you for your letter of 12 July concerning the proposed inquiry into the NHS supplied infected blood.

We appreciate that the form the inquiry takes is yet to be agreed, however, we would wish to see that the Terms of Reference are agreed UK wide. The issue was discussed during a topical question raised in the National Assembly for Wales on 12 July. A full transcript can be found at: National Assembly for Wales Record of Proceedings

This letter represents the initial view of parties within the National Assembly for Wales following that discussion.

We would like to see a commitment to engage and listen to those affected in Wales either individually or through their representative groups, in both setting the remit and in the taking of evidence. Although we have not had the opportunity to engage in depth with those affected since the announcement of the inquiry, we believe that the 10 points raised by the Haemophilia Society broadly cover the areas that most of those affected would wish the inquiry to cover. We expect the NHS in Wales to co-operate fully with the inquiry in providing information requested. Similarly, we would expect the same approach to be taken by the NHS in England and the UK Government to ensure that we maximise the information available to the inquiry. We note that the Scottish Government has referred you to the significant information already available as a result of the Penrose Inquiry.

Naturally, we expect families in Wales to be part of the pre-inquiry engagement in the remit and powers of the inquiry. We look forward to meaningful engagement between the four Governments of the UK in taking this matter forward.

We are copying this to the Secretary of State for Wales, the Minister for Mental Health and Care in England, the Cabinet Secretary for Health and Sport in the Scottish Government and the Permanent Secretary at the Department of Health in Northern Ireland.
