Lesley Griffiths: The Welsh Government's waiting times policy is for 95% of patients to wait less than 26 weeks from receipt of their referral in the hospital to the start of treatment, including the waiting time for specified diagnostic test and therapies, with a maximum wait of 36 weeks to allow for clinically complex cases. All patients should be treated within this maximum waiting time and in order of their clinical need, as determined by the appropriate consultant.

Lesley Griffiths: The most recent Health Board and Trust workforce plans for 2010-11 do not indicate there have been any widespread difficulties in recruiting to medical posts in dermatology. However, our medical recruitment campaign consists of a range of activities which aim to ensure we have clinicians filling all key posts in Wales. We have so far developed a bi-lingual website, targeted recruitment fairs, celebrated achievements and engaged with clinicians to ensure we fully understand the benefits and any barriers to working in Wales.

The Minister for Housing, Regeneration and Heritage (Huw Lewis): A wide range of investment, by various parts of the Welsh Government as well as other delivery partners, has regeneration impacts benefiting communities throughout Wales. We do not currently hold information on the full range of investment in the towns specified, or over the timescale you have requested. However, we are able to provide figures relating to the designated Regeneration Areas, within which some of the towns are located. Please note that:

- Although match funding has been sought from local authorities and other delivery partners where appropriate, this has not (to date) been a formal condition of grant.
- Projects and activities are not always led by local authorities as we have many delivery partners.
- This response does not take into account a scenario whereby local authorities lead on and deliver projects with match-funding from other sources, but do not necessarily provide their own contributions.

Aberystwyth

During 2010/11 and 2011/12, £1.6m was invested by the Welsh Government through the Aberystwyth Regeneration Area programme, with Ceredigion County Council investing £100k. These figures relate to "regeneration"-badged investment only and do not include funding levered in from other parts of the Welsh Government.

The remaining Welsh Government funding for the programme (£8.7m) will be invested during 2012/13, 2013/14 and 2014/15.

Barry

During 2010/11 and 2011/12, £5.5m was invested by the Welsh Government through the Barry Regeneration Area programme, with the Vale of Glamorgan investing £1.6m. These figures relate to "regeneration"-badged investment only and do not include funding levered in from other parts of the Welsh Government or invested through other Council projects and programmes.

The remaining Welsh Government funding for the programme (£4.3m) will be invested during 2012/13 and 2013/14.

Prestatyn (part of the North Wales Coast Regeneration Area - covering the coastal strip between Prestatyn and Colwyn Bay)

A total of £253k has been spent in Prestatyn on regeneration projects with a further £32k coming from Denbighshire County Council. There is no anticipated further funding in Prestatyn, although small scale applications could come in through the community fund. The relatively low level of expenditure is due to the fact West Rhyl is the priority for regeneration areas within North Wales Coast.
