The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies): The Glastir All-Wales Element and ACRES element become operational on 1 January 2012 and the Targeted Element from 1 January 2013. The estimated administration costs associated with the set-up of the Glastir scheme are:

2010

£2.5 million of which £1.0 million is part-funded under the Technical Assistance axis of the Wales Rural Development Plan

2011

The estimated costs are £2.9 million and £1.2 million respectively

The net costs are met from existing Welsh Government administration budgets. The EU funding has been approved by the European Commission.

The Minister for the Environment and Sustainable Development (John Griffiths): Technical Advice Note (TAN) 6 Planning for Sustainable Rural Communities requires local planning authorities to maintain a register of rural enterprise dwelling applications that have been granted or refused over the period 1 April to 31 March each year. Planning authorities are asked to submit this data to the Welsh Government annually. Data is currently being received for the first year, which runs from July 2010 to March 2011, due to the TAN 6 publication date.

Numbers of rural enterprise dwelling applications granted will be made available once all planning authority returns have been received and the results have been assessed.

John Griffiths: Technical Advice Note 6 Planning for Sustainable Rural Communities requires local planning authorities to maintain a register of rural enterprise dwellings granted or refused planning permission. Planning authorities are requested to submit this information annually to the Welsh Government for analysis. Planning authorities are also required to monitor the occupancy of rural enterprise dwellings to ensure compliance with occupancy conditions set out in TAN 6.

Two research projects are underway to prepare practice guides to support the implementation of TAN 6. Firstly, guidance to provide further technical support Rural Enterprise Dwelling Appraisals, and secondly guidance on how to submit and assess applications for One Planet Developments. Both guides will provide further details on monitoring requirements. They will be completed by the end of the year and will be accompanied by training or dissemination events.

The Minister for Local Government and Communities (Carl Sargeant): The Atkins review concluded that the Network Rail Grip 3 report is robust. It did, however, identify 31 technical queries. These relate to items such as: signalling types and numbers, track re-instatement specification, cabling route work, axle counters, evaluator numbers, track drainage and telecoms.

I am currently prioritising the objectives of the National Transport Plan to ensure existing transport funding is used effectively and the level of resources are enhanced. A rescheduled delivery plan will be published this Autumn. The next stages of the project to deliver passenger train services between Ebbw Vale and Newport will be considered as part of the National Transport Plan prioritisation, and the technical queries referred to will be considered at this time.

Assembly Commissioner (Angela Burns): The current official vehicle is the subject of a contract hire agreement which expires in October 2012. The lease term is for three years, costing £7,889.64 per annum. This includes servicing, maintenance and breakdown cover.

The last official vehicle was purchased outright. If the purchase cost is spread over the four and a half years that the last vehicle was owned by the Assembly, the result is about £8,800 per annum. Servicing and maintenance was additional to this. The sale of the car realised £6,300.

With regard to the cost of the official car provided for use by the Presiding Officer and the Deputy Presiding Officer, it is not possible to provide an actual cost associated with the driver of the vehicle. During 2007 the driver's contract was changed and his duties now include support to the Deputy Presiding Officer and administrative work as a member Presiding Officers' private office. Consequently driving is now just one element of the post holder's duties. However I can advise that the pay scale appropriate to the grade of the post is currently between £17,410 and £20,483. Details, per annum, are contained in the table below:

Angela Burns: Detailed costs for the Assembly Policing Unit are listed in the tables attached. We do not have the broken down cost for 2008-09, additional work would be needed to produce that information if required. "Other" costs relate to the purchase of specialist equipment, travel and accommodation which vary month by month depending on the particular duties undertaken by officers. The increase in budget between 2008-09 and 2009-10 relates to the secondment of two additional full time Police Officers to provide weekend working arrangements. During this period a Police Sergeant also retired and was not immediately replaced which also impacts on the overall cost.
