b) confirm which councils did not fulfill Welsh medium requests for childcare under the Flying Start scheme? (WAQ94839)

The Minister for Communities and Tackling Poverty (Huw Lewis): The Flying Start programme makes an offer of childcare to the parents of all eligible children, as opposed to responding to a request from a parent. No data is therefore collected on the number of parental requests for childcare. I can however confirm that the local authorities do record the number of new offers of full or reduced childcare made in each term: in 2012-13 the total number of new offers made was 5,221 and this is broken down as follows:

Once an offer of childcare has been made by the local authority then the parent's choice of language can be discussed.

It was a new requirement in 2012-13 to collect data relating to language preferences and at present the data we have is not sufficiently robust at an individual local authority level to provide an assessment at that level of whether specific Welsh medium requests have been fulfilled or otherwise. I am therefore unable at this time to provide you with the information you have requested. I have however asked my officials to contact all the local authorities and establish how many of the requests for Welsh medium childcare made in 2012-13 they were unable to fulfil. Once this information is available I will be happy to let you have it along with the information that has been requested about the number of Welsh medium childcare settings and the number of places available.

Edwina Hart: The Welsh Government provided funding of around £5m between 2001 & 2008 to the Isle of Anglesey County Council to support their Holyhead Environmental Package project which included the Gateway Bridge and the Causeway Link. These projects were procured and delivered by the Council who will hold full details of the funding and costs associated with the various works.

The Minister for Health and Social Services (Mark Drakeford): The Welsh Government has not had discussions with the Department of Health about the potential introduction of a meningococcal B vaccine programme.

The Welsh Government responds to recommendations from the Joint Committee on Vaccination and Immunisation (JCVI) on the introduction of new vaccination programmes.

The Joint Committee for Vaccination and Immunisation (JCVI) is considering evidence on the epidemiology and carriage of different meningococcal serogroup B strains, the costs of treating the disease and the long-term conditions that result from the disease as well as the quality of life of the affected individual and will make recommendations on completion of their evaluation

In the meantime, officials are maintaining regular contact with the Department of Health and JCVI to monitor progress and to update the Chief Medical Officer on developments.

Mark Drakeford: NHS Wales and the Department of Health have not met to discuss the introduction of a meningococcal B vaccine into the routine childhood immunisation schedule.

As with the other three UK countries, the Welsh Government responds to recommendations from the Joint Committee on Vaccination and Immunisation (JCVI) on the introduction of new vaccination programmes.

The JCVI is considering evidence on the epidemiology and carriage of different meningococcal serogroup B strains, the costs of treating the disease and the long-term conditions that result from the disease as well as the quality of life of the affected individual and will make recommendations on completion of their evaluation.

JCVI recommendations and the implications for Wales will be considered by the Chief Medical Officer and the Wales Immunisation Group before a decision on the introduction for a meningococcal B vaccine programme is be taken.

Mark Drakeford: The Welsh Government responds to advice and recommendations from the Joint Committee on Vaccination and Immunisation (JCVI) on the introduction of new vaccination programmes. The JCVI is an independent, expert panel which advises all UK countries on immunisation issues.

The Welsh Government is not required to implement the advice and may adopt a different approach to the other three UK countries if it considers there are reasonable grounds for doing so.

The Welsh Government works with the Wales Immunisation Group, Health Boards and general practitioners to ensure that vaccines are delivered to patients in the most effective manner.

The Welsh Government is able to utilise UK level purchasing arrangements managed by the Department of Health in England.

The Minister for Local Government and Government Business (Lesley Griffiths): The key performance indicators relate to the performance in delivering Local Authority services rather than performance in recruiting women into senior management posts in Local Government. Therefore, I have no plans to introduce an indicator to measure the percentage of women in senior management posts in Local Government. However, I encourage Local Authorities to ensure they are fully meeting all their responsibilities under the Equality Act and the Wales Specific Duties.
