**THE SWEETENERS IN FOOD (AMENDMENT) (WALES) REGULATIONS 2002**

**Background**

These Draft Regulations were laid before the National Assembly for Wales on 15 January 2002, considered by the Business Committee on 15 January 2002 and by the Legislation Committee on 29 January 2002.

The need for certain drafting changes was identified to the Legislation Committee prior to the Committee's meeting and the amendments suggested in consequence.

The amendments were reported and agreed by the Legislation Committee in its meeting on 29

January 2002, for consideration by the Assembly as follows:-

## **Amendments**

*All amendments are to both the Welsh and English texts unless specifically stated otherwise.*

### **1. The Schedule (page 9 )**

**In the Schedule in the entry for Mustard** - omit the expression "140 mg" and insert the expression "140 mg/kg" in the second column and make the equivalent amendment to the Schedule in the Welsh text.
