Wrexham County Council submitted a bid for a Welsh Medium Primary School in May 2010 as part of the Tranche 3 bid process. The Welsh Assembly Government announced approval in principal for the project on 14th July 2010. The local authority has confirmed that outline planning permission for the new school in Gwersyllt has been granted in January 2011. Discussions are continuing between Welsh Assembly Government officials and the local authority to agree the timescale for funding the project.

The Appetite for Life Action Research Project, launched in September 2008, was designed to test and inform the development of the guidelines for implementing the food, drink and nutritional standards proposed for schools in Appetite for Life. Based on the information gathered throughout the lifetime of the project, three versions of the draft guidelines have been published, with work currently under way on the final version. These guidelines include a section on 'Managing different dietary needs'. This section advises that, to provide a special diet, schools and local authorities may need to work in partnership with a number of people, including parents/carers, dieticians, school nursing services, catering staff, midday supervisors, and teaching and support staff, to ensure the needs of the individual pupil are met. The Sustainable Development Fund has been invaluable to a large number of local and community projects in Wales' three National Parks and five Areas of Outstanding Natural Beauty, and has enabled a lot of good work to be done over the past ten years.

In 2010/11 the Fund was allocated £1million with £650,000 going to the National Park Authorities and £350,000 going to the AONBs. Due to the current financial climate the Sustainable Development Fund will need to be reduced over the next three years in line with the revenue reductions across the Department.

It is my intention that these reductions will be met equally across the board. This will mean that the National Parks will receive £624,000 in 2011-12, £595,000 in 2012-13 and £566,000 in 2013-14; and the AONBs will receive £336,000 in 2011-12, £315,000 in 2012-13 and £300,000 in 2013-14. These allocations would then be split equally among the three NPAs and five AONBs respectively.

On this basis the Clwydian Range AONB will receive £67,200 in 2011-12, £63,000 in 2012-13 and £60,000 in 2013-14.
