**The Deputy Minister for Agriculture, Food, Fisheries and European Programmes (Alun Davies):** Illegal Fishing activity, once detected, is dealt with through prosecution, written warning and suspension of licences.

Since 1 April 2010 the Environment Agency (EA) has been managing the Cockle fisheries at the Dee Estuary and Burry Inlet on behalf of Welsh Ministers. During 2011, the EA's management of these fisheries resulted in a total of approximately 20 tonnes of illegal cockles being seized, with 14 prosecutions, 4 formal cautions, 7 warning letters and 15 suspensions of licences. This was a visible increase in enforcement action from 2010, where 7 formal cautions, 18 warning letters, and 5 suspension of licences were recorded.

The Welsh Government took direct control of intertidal fisheries around the Wales coastline on 1 April 2010. Officials' actions resulted in 3 prosecutions and 4 written warnings during the 2010 and 2011 period.

Enforcement of the scallop fishery has been undertaken by Welsh Government officials both at sea and ashore, resulting in 9 prosecutions and 7 written warnings. Of these, two were taken against non-uk registered vessels.

**The Deputy Minister for Children and Social Services (Gwenda Thomas):** I am responding to your recent question to the Minister for Education and Skills as the learning disabilities agenda falls within my portfolio.

Our White Paper "Sustainable Social Services for Wales a Framework for Action" sets out the Welsh Government's response to the findings of the Independent Commission for Social Services about the challenges facing service delivery.

*"Sustainable Social Services"* set out how the Welsh Government will take forward social services and social care policy to develop the high quality, responsive, citizen-centred social services that are essential to a successful Wales. This is an ambitious agenda for change and one that we can only deliver successfully by working closely with our partners across Wales. At the heart of this is the need to ensure that citizens have a stronger

voice and real control over services.

Our exercise to appoint the Learning Disability Advisory Group is almost complete and the Group will be of central importance in providing advice to the Welsh Government to inform learning disability policy development within the context of the reform programme set out in *"Sustainable Social Services"*.

The Care and Social Services Inspectorate Wales remains the registration and regulation body when considering new registrations or variations to existing registrations for care homes for younger adults in Wales.

The business case assumes that where the provision of service to Forestry Commission Wales is withdrawn, there could be an increase in the residual unit costs for the remainder of the Forestry Commission. These additional costs have been accounted for in the net benefits estimate within the economic case.

**John Griffiths:** The business case has the most recent estimates. The cost benefit calculation assumes that Welsh Government continue to pay for a range of services ( $\pounds$ 17.5m over the 10 years of the business case) .Additionally, some  $\pounds$ 6.6m of service costs has been included to reflect loss of efficiency within Forestry Commission GB. ICT cost provision of  $\pounds$ 1m over and above running costs is included for Forestry Commission transitional costs to cover potential due diligence, connectivity and information assurance issues.

This is included within the  $\pounds$ 30m provision for ICT change costs, which also allows for a substantial contingency provision. Some of this would also be allocated to Forestry Commission continuity and transition. The business case also includes provision for additional staff costs to cover transitional work.

The Minister for Finance and Leader of the House (Jane Hutt): We have consistently said that the UK Government has imposed cuts that go too far and too fast and risk a major impact on jobs, services and the economic recovery in Wales. Our Budget for Growth contains a series of measures which will support people, communities and the economy the length and breadth of Wales.

With women making up a significant proportion of the public sector workforce in Wales, our support to help people back into employment is important for our female workers. That is why we provided an additional £15 million for Adapt in our Budget for Growth and Jobs to continue support for displaced public sector workers.

I introduced the carrying out of detailed equality impact assessments as a key part of our annual Budget process to reassure ourselves and the people of Wales that the actions taken will not impact adversely upon disadvantaged groups, including women.

On 2 April the Welsh Government published its Strategic Equality Plan and equality objectives to advance equality in Wales. As an example, public authorities that identify a gender pay difference must either set a gender pay equality objective to address the cause of the pay difference or explain publicly, why they have not done so.

Derbyniwyd ateb i'w gyhoeddi ar 12 Ebrill 2012 Answer received for publication on 12 April 2012 **The Minister for Health and Social Services (Lesley Griffiths):** The Welsh Government is committed to improving accessibility of GP services for working people by ensuring appointments are available at times which are convenient to them.

The initial focus is on redistributing appointments during contracted core hours towards the latter part of the day - from 5:00pm to 6:30pm. I expect the first stage of this work to have been completed by the end of March 2013. There are no additional costs associated with redistributing appointments within core hours.

The next stage will focus on extended opening and access to appointments beyond 6.30pm. Whilst there is already access to appointments after 6.30pm in some GP practices, this will be extended more widely across Wales from April 2013, where there is evidence of demand.

In relation to access on Saturday mornings, I have commissioned work to develop an innovative model for access to planned appointments on a locality basis. This review is expected to be completed shortly.

The intention is to deliver this commitment within existing budgets, by reviewing and prioritising current funding.

Any additional information provided will be incorporated into the final impact assessment and taken into consideration before a final decision is made.
