
These signatures follow a casual discussion and request for support by me over a two week period in a small area of the River Dee Catchment in North Wales.

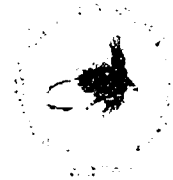

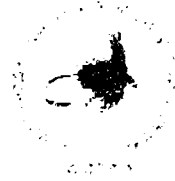

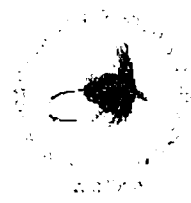
