The Minister for Education and Skills (Huw Lewis): For 2013-14, individual school allocations are determined on the basis of £450 per pupil, aged 5-15 and eligible for free school meals, and the number of looked after children aged 4-15. We have published proposals in the draft budget to more than double this support in 2014-15 by increasing the amount per child to £918.

Across Wales in 2013-14, the Pupil Deprivation Grant (PDG) is providing £33.3 million to help schools tackle the barriers to learning for children and young people from disadvantaged backgrounds. Under the draft budget proposals, this will rise to over £71m in 2014-15. This is a further important contribution to breaking the link between poverty and educational attainment

The funding is allocated to regional consortia, which are charged with delegating 100% of the grant to schools. This provides consortia with leverage to support and challenge, through their Systems Leaders, the use of the grant by schools. For that reason, information regarding individual school allocations is not held centrally. However, under the terms and conditions of grant, each school is required to publish its PDG allocation on its website. Match funding of the PDG up to £3 million over 2013-14 and 2014-15 is also available under the Communities First Programme. A further £3.5 million has been allocated in 2013-14 to the National Support Programme to upskill the workforce to tackle the impact of poverty on educational attainment, and for development work.

For broader interventions to improve literacy and numeracy and reduce the impact of poverty on educational attainment, support is provided through the School Effectiveness Grant (SEG). For 2013-14 the total SEG amounts to more than £37.4 million of additional support.

The management agent will also support the young person to update their CV and help with any transition into further learning. In addition, the Management Agent will refer them on to Careers Wales who will undertake an impartial careers advice and guidance interview.

Derbyniwyd ateb i'w gyhoeddi ar 14 Hydref 2013 Answer received for publication on 14 October 2013 **Huw Lewis:** There is no clear relationship between council size and secondary school bands for schools within the local authority area.

The secondary school banding data for 2012 shows that some smaller local authorities such as Denbighshire perform well (all eight schools are in Bands 1 to 3), while others such as Merthyr Tydfil don't perform so well (all four schools are in Bands 3 to 5).

The same is true of larger local authorities. Swansea has eleven of its fourteen secondary schools in Bands 1 to 2, while Rhondda Cynon Taf has seventeen of its nineteen secondary schools in Bands 3 to 5.

Huw Lewis: Estyn's inspections of the quality of Local Authority Education Services for Children and Young People cover a far broader range of considerations than the secondary school banding model. Secondary school banding has been developed to identify schools that are in most need of support by considering school performance data alone.

It is reasonable to expect that banding and inspection outcomes will generally show similar positive or negative trends but they will not align as such. For example Estyn has placed Blaenau Gwent County Borough Council in Special Measures and all of its five secondary schools are in Bands 3 to 5. Similarly Denbighshire County Council had an overall judgement of 'Good' in its Estyn inspection and all eight of its secondary schools are in Bands 1 to 3. However, Estyn placed Pembrokeshire County Council in Special Measures and all of its eight secondary schools are in Bands 2 to 3.

The Deputy Minister for Children and Social Services (Gwenda Thomas): The Welsh Government requires all independent providers to be registered, and to meet standards set out in regulation in order to operate in Wales. These regulations include workforce standards and are regularly checked by Local Authority commissioners, and inspected by CSSIW.

In addition, the Welsh Government supports training of social care workers in the public and independent sectors through a grant of £8 million a year.

We also provide £10 million a year to fund the Care Council for Wales, the social care workforce regulator and development body. Key staff are required to register with the Council and hold specified qualifications. This includes the managers of all residential and domiciliary care provided by the independent sector.

The Care Council has also produced an induction framework to ensure the sound preparation of new staff and practice guidance which describes the responsibility of managers to induct, supervise and train their staff.

It is encouraging to note that qualification levels in the social care workforce have risen sharply through the last 10 years. The Government is currently consulting on a range of proposals related to workforce development through the White Paper 'The Future of Regulation and Inspection of Care and Support in Wales.'

Gwenda Thomas: The Welsh Government supports the continuing professional development of social workers and social care workers by providing £8 million a year to fund targeted training across the social care sector.

We also provide £10 million a year to fund the Care Council for Wales, the social care development body. It is building upon existing post qualifying training by putting in place continual professional development (CPD) arrangements for social workers to support them at each stage of their career. It is also developing career pathways and CPD arrangements for social care workers, beginning with managers.

In addition, the Welsh Government provides funding to the Social Services Improvement Agency which has developed and ensured access to leadership development for social work team managers.

Continuing workforce development will also be taken into account as part of the implementation planning for the Social Services and Well-being Bill, to ensure that we have a workforce equipped to work in the new ways needed to provide citizen centred care.

Finally, the Government is currently consulting on a range of proposals related to workforce development through the White Paper 'The Future of Regulation and Inspection of Care and Support in Wales.'
