Political membership of political parties (ASPBs)

You recently asked a series of questions about the registered membership of political parties of board members of Assembly sponsored public bodies (ASPBs) (WAQ22715; WAQ22716; WAQ22717; WAQ22719; WAQ22720; WAQ22721; WAQ22722).

In my reply I explained that information on appointees' membership of political parties is not collected. However all candidates for public appointment are asked to complete a question on political activity in their application form. A copy of the form they are asked to complete is at annex B.

This information has now been collated and is shown in the table at annex A.

You will see that, for a small minority of post holders, the information is not available. In two cases the post holder has indicated that they have been involved in political activity but have not specified the political party. There are also some ASPBs that either have no appointees in post at present or whose members are not appointed by the Welsh Assembly Government.
