**Antoinette Sandbach (North Wales):** Given the recent press that universities consider Crest Awards in applications for undergraduate places, will the Minister detail her position on the importance of the Crest Awards, administered through See Science? (WAQ65918)

**Antoinette Sandbach (Gogledd Cymru):** A wnaiff y Gweinidog gyfiawnhau tynnu cyllid yn ôl o Ddyfarniadau Crest, drwy Gweld Gwyddoniaeth, gan ystyried yr angen i annog mwy o ferched i ymgymryd â phynciau STEM? (WAQ65919)
