**The Minister for Culture and Sport (John Griffiths):** The Welsh Government via Sport Wales are providing £815k this year to the Welsh Football Trust. This funding is used to increase overall participation rates by children, especially amongst Disability and BME groups. It also supports coach education programmes and assists in ensuring that there are structures in place to nurture and develop our more talented players. Collectively this supports the overall development of grassroots football across Wales.

The Welsh Government does not provide any funding to the FAW or the FAW Council.

**The Minister for Natural Resources and Food (Alun Davies):** The Welsh Government is developing its biodiversity strategy as a part of our obligation to achieve the key aim of the European Union Biodiversity Strategy of halting the loss and reversing the decline of biodiversity where possible by 2020.

To help identify the priorities for biodiversity action in Wales I will be holding a Summit at the Royal Welsh show this week in response to the publication of the State of Nature report.

I have commissioned an audit of Welsh data. Following its completion the Strategy Board will recommend a clear course of action.

**Alun Davies:** Welsh Government priorities for Natural Resources Wales have been set out in the 2013/14 Remit letter, its Performance Framework and the Natural Resources Body for Wales (Functions) Order 2013. Natural Resources Wales is now in the process of developing its 2014 -17 Corporate Plan to deliver against Welsh Government priorities, and I do not intend to issue new guidance at this time. I am, however, considering the functions of the new body in developing proposals for the Environment Bill. This may include powers in respect of statutory guidance.
