In my response to your written Assembly Question, tabled on 25 November 1999 and answered on 29 November, I undertook to write to you with information about how far authorities have been spending above their standard spending assessment in 1999-2000, and how moving total standard spending for 2000-01 into line with actual budgets affected individual authorities.

This information is now available, and I attach an explanatory note and tables, which I hope will be useful.

dwelling well below band D). Increasing the level of TSS also increases the council tax for standard spending and hence accentuates the difference in relative shares of RSG.

The data effects are the result of the sort of changes in input data that are experienced each year — there were no formula changes of any consequence for 2000-01. They can not be avoided nor do they give any indication of the effects for individual authorities in future settlements.

Only Monmouthshire has an interaction effect that is of any significance and that compounds the reduction in grant due to methodology and data effects.

#### Council tax levels

The changes in grant shown in Table A do not show a direct correspondence with the changes in council tax levels shown in Table B; there are two main reasons for this

- the overall increase in council tax due to revised budget assumptions;
- differential changes in taxbase between the 1999-2000 and 2000-01 figures (particularly for Caerphilly who are not damped and increased their assumed collection rate by 1 per cent, hence the decrease in council tax due to budget assumptions/ taxbase);

However, the general pattern is similar to that seen in Table A.

## Conclusion

The allocation of grant was, naturally, affected by the changes in data and assumptions since the Partnership Council meeting in October. Increasing TSS for councils into line with budgets, as desired by the Welsh Local Government Association, reduced grant allocations for several authorities. In many cases, the effects of data changes on grant and council tax were more significant. Monmouthshire and the Vale of Glamorgan experience the largest potential impact on council tax as a result of the increase in TSS.
