The Minister for Education and Skills (Leighton Andrews): My officials continue to work with HEFCW on a range of positive interventions to promote national strategic priorities, such as STEM. For example, HEFCW has joined the National STEM Programme and is investing £1m over three years from 2009/10 across a range of activities in all the main STEM areas.

HEFCW funding recognises both the additional costs and the strategic importance of STEM subjects through higher units of funding for STEM. In 2010/11, the Council approved the introduction of a STEM incentivisation redistribution process and the commitment of £250k for this purpose.

The new arrangements for student finance and fees in Wales from 2012/13 enable providers of higher education to charge tuition fees up to £9,000 per annum from 2012/13 provided that they have in a place a fee plan approved by the Higher Education Funding Council for Wales (HEFCW).

The new student support package will entail a shift in the balance of teaching funding in Wales to mainly student fee-led. There will be a balance of funding which will remain with HEFCW and which will become a new Public Investment Fund. That Fund will support activity which reflects priorities set out in our HE strategy, For our Future. In my Remit Letter I have asked HEFCW to develop a new funding approach for this Public Investment Fund to take effect from 2012/13 and I expect the Council to continue to focus on the increased delivery of subjects of strategic importance, including Science, Technology, Engineering and Maths (STEM).

2010/11: Figures for 2010-11 have not yet been finalised. Based on current information we anticipate total spend for the primary school free breakfast initiative for 2010-11 to be around £11.3m.

Projected total costings: From the outset, the Welsh Government has made clear that participation in the scheme is voluntary and that we will provide the necessary funding for those schools and children who wish to do so. Provision for free breakfasts is demand—led. The Assembly Budget for the next 2 years includes provision for this initiative as follows:

2011-12 £10.7m

2012-13 £12.7m – this is indicative until the outcome of the Resource Assessment Exercise 2011 and approval of the Final Budget in early 2012.

**John Griffiths:** Since the introduction of the Clean Neighbourhoods and Environment Act on 6 April 2008, the responsibility for stray dogs falls to local authorities in England and Wales. To support this

legislative change, additional funding of £326,000 has been made available to local authorities via the Revenue Support Grant (RSG). In addition to this funding each local authority is able to claim £25 plus expenses from the owner of each stray dog reclaimed.

The allocation of resources from the RSG for stray dog services in Wales is a matter for each individual local authority to determine based on the local level of service required.

The Minister for Health and Social Services (Lesley Griffiths): I very much welcome the new NICE guidance on the management of hip fractures in adults, and expect the NHS in Wales to take full account of its recommendations when planning and providing services for their patients. Hip fractures are a serious problem and the evidence suggests timely surgery can significantly improve mobility and independence among this group of patients. NICE says the changes it recommends would cost comparatively little to implement and likely to save money over the longer term.

**Lesley Griffiths:** The £65m funding is to be used to develop sustainable solutions to increase capacity and reduce demand for orthopaedic services. Plans are in place to increase capacity, including the building of two modular theatres in North Wales, employing additional consultants. Across South Wales, LHBs are exploring innovative ways to reduce demand across the Region, these plans are currently being finalised.

In year 1, the NHS will receive £21m with £11.6m allocated on a recurrent basis, the remainder on a non-recurrent basis, and we will ensure sustainable solutions are put in place for our patients.

Lesley Griffiths: We have recently completed a three month public consultation on the draft All Wales Catering and Nutrition Standards for Food and Fluid Provision for Hospital Inpatients. These Standards will build on initiatives already in place such as the All Wales Nutrition Care Pathway and food record charts, and aim to raise the importance of catering and nutrition to an essential part of the care patients receive in hospitals. The Standards are currently being revised in line with the results of the consultation and will be published in September.

To accompany these new Standards we have also developed guidance for supporting healthy food and drink choices for staff and visitors in hospitals. We are currently consulting with hospital caterers and dietitians on this guidance and, when we publish it later this year, it will include updated Health Promoting Hospital Vending Guidance for Local Health Boards to follow.

#### Peter Black AM, on behalf of the Assembly Commission:

There is currently only one special adviser employed by the Assembly Commission; a Finance and Corporate Governance Adviser. The Adviser was appointed on 1 July 2007 on a part-time basis, to provide high level advice and assistance on financial-related matters for the Assembly's Finance Committee and to provide specialist advice to the Assembly Commission, Presiding Officer and the Assembly's senior management on matters relating to finance, governance and audit.

Within the last five years, the Assembly Commission has employed one other special adviser; that of Adviser to the Presiding Officer. The Adviser was appointed on 28 May 2007 and their role was to provide specialist advice to the PO on policy and constitutional matters.

Providing information on the annual costs of these two appointments may involve data protection issues and further time is needed to explore these fully. A further response will be provided as soon as possible. In addition the Assembly has four independent advisers, each engaged on a contract for services rather than as an employee, who were appointed on 5 November 2007. Their role is to ensure that the Assembly Commissioners and the Assembly's senior management are supported and constructively challenged in their roles, by providing an external perspective. Their responsibilities include reviewing organisational performance and maintaining a critical overview of the Assembly's financial controls and risk management procedures.

The total annual cost for all four advisers was as follows (rounded to the nearest £1,000):

The Assembly also engages a Chair of the Independent Remuneration Committee on a contract for services rather than as an employee. He was appointed on 24 January 2008. The role of the Committee is to assist the Assembly Commission in discharging its duty to ensure high standards of corporate governance and financial control by considering recommendations and proposals on pay strategy. The annual cost was as follows (rounded to the nearest £1,000):
